Health department hours unchanged

Hours at the Marshall County Health Department will remain unchanged for now, county commissioners decided Monday.

Health department director Cheryl Skalla told commissioners that since the department went to a new schedule in September, employees had seen 134 people before 8 a.m.

The department is open from 7:30 a.m. to 5 p.m. Monday, Tuesday and Thursday and 7:30 a.m. to 6:30 p.m. on Wednesdays.

In October, 302 people visited the health department after 5 p.m. on Wednesdays.

The department offers its WIC clinic (Women, Infant Children) on Wednesdays. The program is for mothers and children up to age 5. Often the small children also need vaccinations. The later hours are intended to help working families.

After reviewing the information from Skalla, Commissioner Jon Ungerer said it appears the early-morning visits have "kind of caught on and picked up."

A couple of calls about the change in

hours came to him early in the process, Ungerer said, but nothing since.

"Normally if somebody's got a concern, they'll call you," Ungerer said.

"People are really, really enjoying it," Skalla said.

"People seem to be happy," Commissioner Fritz Blaske said.

Commissioner Keith Bramhall told Skalla to continue to keep statistics on usage patterns for her department.

Commissioners plan to look at hours for other county offices again in December and will schedule a December department head meeting. New hours for some other county offices began Sept. 3, and the commissioners said they would evaluate the changes in December.

They realized Monday that Dec. 20, the last day for payment of the first half of taxes is on a Friday. The treasurer's office has been closing at noon on Fridays, along with the clerk, appraiser, register of deeds and emergency management offices. The commissioners plan to have more discussion about how to handle the Dec. 20 tax payment deadline.

Questions about specific office hours can be referred to the individual offices.

Grant received for siren

The city of Blue Rapids has received a \$15,690 grant from the Federal Emergency Management Agency Region 7 for a siren replacement and upgrade project.

The project is to fund the replacement of an existing 80-year-old emergency warning siren. The existing siren pole is decaying, and a new pole will be placed in the same location on Ninth Street between Lincoln and Main streets, to support the new siren.

The siren will have a 12-volt backup battery system and will be powered via the existing overhead lines.

Marshall County commissioners will meet twice next week — at 8:30 a.m. Tuesday instead of Monday because of the Veterans Day holiday and at 8:30 a.m. Nov. 14 to canvass the general election ballots.

llots. At their meeting Monday, commissioners worked on details for a sale notice for 6.2 acres the county owns on 11th Terrace north of Subway. The notice must be published three times and is subject to petition. Commissioners have to wait 45 days from the date of the first publication to take action, in case a petition is submitted.

They plan to accept sealed bids for the property due at noon, Dec. 27. Commissioners could consider the bids at their Dec. 30 meeting.
