

Officers Not Alarmed Do Not Place Much Faith in Alleged Cattle Thefts.

> As a matter of fact, it is stated, by some citizens of the counties where the trouble is, that there is no cattle stealing going on. There seems to be a feud of some kind among the cattle men, and apparently one side is trying to get the others arrested for cattle stealing.-Topeka Herald.
