## Vanderford takes plea, sentencing scheduled

Timothy Vanderford of El Dorado has taken a plea deal in his case. He was arrested by the El Dorado Police Department on April 23, 2023 after holding a 63-year-old female hostage at gunpoint in their home.

He was initially charged on five counts; one count of attempted 1st degree murder, one count of aggravated kidnapping, aggravated burglary, one count of criminal discharge of a firearm, and one count of aggravated domestic battery. During his plea hearing on June 25, Vanderford accepted

a plea of to one count of kidnapping and one count of aggravated burglary. The other three counts were dropped by the state.

Vanderford will be sentenced at 1:15pm on August 26 in front of Chief Judge David Ricke.

## Bagley takes plea, scheduled for sentencing

Lillian Bagley of El Dorado has taken a plea deal in a child pornography case. She was arrested on February 26 by the El Dorado Police Department and was charged with three counts of indecent liberties with a child who is less than 14 years old, two counts of aggravated internet trading in child pornography wherein the child is less than 14 years old, and six counts of sexual exploitation of a child who is less than 14 years old.

Bagley will be sentenced at 11am on August 23 in front of Chief Judge David Ricke.


