Word was received Thursday, Sept. 5 from Linn County Clerk David Lamb that he had received the resignation of Linn County Sheriff Kevin

Friend that morning effective Sunday, Sept. 22.

Friend wrote in his letter of resignation,

"To: Governor Laura Kelly
Citizens of Linn County
Linn County Clerk and
Election Officer

"Re: Resignation

I would like to thank the citizens of Linn County, Kan. and the supporters of the Linn County Sheriff's Office for the unwavering support over the past four years and eleven months. I have enjoyed serving Linn County as your Sheriff since my appointment on October 2, 2019. I have accepted another position and my final day as Sheriff of Linn County will be September 22, 2024.

"I appreciate and admire the staff of the Linn County Sheriff's Office, and I am

proud of their achievements. I thank you for the opportunity to serve and I pray for God's blessings on our county.

Lamb outlined a brief scenario of how the replacement of Friend would occur with notice first going to the Linn County Republican Central Committee who will nominate a replacement.

Friend complied with state statutes when he sent his resignation to the governor, Linn County Clerk and chair of the Linn County Republican Central Committee Becky Johnson.

Lamb said that in the interim Undersheriff Bobby Johnson will take over day-to-day duties.

Friend said that he's had Sheriff Elect James Akes working administratively for the past several weeks and felt that Akes is ready to assume the position at this point.

Lamb explained that the Sheriff's appointment is handled by the governor in the same manner as a member of the House of Representatives, should one of them resign.

Johnson will call a convention of countywide precinct people to convene; those people will appoint a person to hold the office of Sheriff during Friend's last day and the day Akes takes office in January. The recommendation by the precinct officers will go to Governor Kelly for approval before that person assumes the position of interim Sheriff.

Commission adopts 2025 county budget

In theory, budget is revenue neutral except for 3 attached cemetery districts

Commissioners unanimously passed Linn County's 2025 budget at their Sept. 3 weekly meeting, delayed a day because of last week's federal Labor Day holiday.

In theory, the county budget remains revenue neutral from 2024, with ad valorem revenue of \$13,625 million equaling that received for 2024. The county tax levy will decrease by 2.751 mills to 38.241 because of the county's valuation increase of almost \$24 million to \$356.3 million.

However, the Commission's unanimous voice vote on Resolution 2024-25 to exceed revenue neutral status comes because of budgets submitted by three cemetery districts (1, 4 and 5), entities that are attached to the county budget rather than to a township.

"They're not governed by the Commission but by a cemetery board," Lamb explained. "They're slightly over revenue neutral because mowing costs have gone up a lot in recent years."

Most of the public comment came during the revenue neutral exceedance hearing, with increased valuations the primary topic.

Harriet Bogan, rural Prescott, said the assessments she had received "were up \$120,000. It's not acceptable. Who assesses? What can we do about it?"

Alluding to assessments coming from the county appraiser's office, Bogan said, "I know it's not your (Commission's) fault, but we've got to do something. It's wrong."

Asking for the Commission to lower taxes, Marjorie


