IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

City of Beloit Has Levels of Total Trihalomethanes (TTHM) Above Drinking Water Standards

Our water system recently violated a drinking water standard. Although this is not an emergency, as our customers you have a right to know what happened, what you should do, and what we are doing to correct this situation.

Drinking water quality samples collected during the 1Q, 2Q and 3Q2024 indicate a locational running annual average (LRAA) of 81 ug/L for TTHM at 120 W 8th St for 4Q2024 compliance. This exceeds the Kansas and Federal (EPA) maximum contaminant level (MCL) of 80 ug/L for TTHM for public water supply systems at any single TTHM sampling point.

What should I do?

You do not need to use an alternative (e.g., bottled) water supply. However, if you have specific health concerns, consult your doctor.

What does this mean?

This is not an immediate risk. If it had been, you would have been notified immediately. However, some people who drink water containing Trihalomethanes in excess of the MCL over many years may have an increased risk of getting cancer.

What happened? What is being done?

Trihalomethanes are compounds formed by Chlorine reacting with certain organic compounds in the water. We are working with Engineers to resolve this issue. As stated, this is not an immediate risk to your health. We will continue to work on this issue until resolved. Kansas Dept. of Health and Environment is reviewing our correction method for this issue.

We anticipate resolving the problem with engineering support and continued testing.
