# Teen killed in Mitchell County

MITCHELL COUNTY (KWCH) — A 17-year-old from Lincoln died from his injuries in a crash reported late Thursday morning on K-14 highway in Mitchell County. The two-vehicle crash happened a little before noon on a stretch of K-14 just south of V Road, the Kansas Highway Patrol (KHP) confirmed.

In the crash, the KHP reported that a 2003 Chrysler Town and Country minivan was traveling east on K-14 as a semi was traveling west.

"For unknown reasons, the minivan lost control and crossed the center line into the westbound lane," the KHP report said. "The semi struck the minivan and entered the north ditch, and both vehicles caught on fire."

The KHP identified the Lincoln teen killed in the crash as Austin Cearyn Jablonski. Jablonski was driving the minivan. The KHP report did not list any passengers in the vehicle. The semi driver was not seriously injured.
