shall widen and narrow within the

revision area. However, the Zone

A special flood hazard area for

the Republican River Tributary will

be removed and replaced with a

shaded Zone X flood hazard that

represents 1% annual chance

flooding with average depths

less than one foot. The shallow

flood depths associated with the

Republican River Tributary and its

overflow areas will be classified as

"advisory" or "other" areas of flood

hazard and will not be classified as

a regulatory special flood hazard

area. As such, many buildings will

be removed from the regulatory

ings will be added to the regulatory
