Harvest is winding down but still a lot of fields to cut. The spotty rains will sometimes let you cut in one end of the field while the other end is too wet. I've also seen some severe tracks in the stubble which is never good. Back when we had mostly pull type combines I remember a classmate telling that they had 4 tractors pulling one combine because of the mud. In those conditions you had best park it for awhile. Years ago we often started on a Monday and was done by Saturday with good weather. The little 5 foot Allis didn't take a big swath but we got it done. When a neighbor loaned us his Allis we really made progress with two of them. Now they move in with a million dollars worth of equipment and get done in a hurry. I guess the biggest John Deere combines now cost a million for just one machine.

I often think of Frank Smith from west of Miltonvale at harvest time. He had a 3 foot Allis combine and he went slow and steady and got his cut in good time. That combine now is at Bennington as John Vern Carson finally talked him into selling it to add to John Vern's collection of Allis equipment.

Just north of Bennington there are hundreds of big round bales of straw in the fields. However, there aren't quite as many as there were. As often happens, a bearing went out in the baler, setting the bale in the chamber on fire. Since you can't always keep track of what is behind you a fire soon gets out of control. It burns through the hydraulic hoses spraying oil all over. Since you no longer have hydraulic pressure you can't dump out the bale or drive. Hydraulic oil burns about like gasoline. This was just two miles from the fire station but the only thing that wasn't burned was the two front tires on the tractor. I noticed the tractor had an auxillary fuel tank on the front that was patented and built by BenCo Mfg. at Bennington but with a Miltonvale connection.

TICKS! They are still around. They are so little they are hard to see but when they burrow in they are sure apparent. They get firmly attached and are almost impossible to pull out. I hope their life cycle is about over.




