2013 Coup in Egypt--Egyptian defense minister Abdul Fatah al-Sisi staged a coup and forced out President Mohamed Morsi, just over a year after he was elected.

1988 Iran Air flight 655 is shot down by a US Navy ship--The USS Vincennes mistakenly shot down the airplane en route to Dubai, killing all 290 people aboard. The Vincennes, a guided missile cruiser, incorrectly identified the plane as a military aircraft. In 1996, the United States government made a cash settlement with Iran in order to close the case Iran had brought against the US in the International Court of Justice.

1962 Algeria gains its independence from France--Algeria's independence from France, after 132 years of French rule, was finalized after the signing of the Évian Accords in the spa town of Évian-les-

long voilent war of independence. Independence was finally achieved after the July 1, 1962, referendum favored complete Algerian independence. Ahmed Ben Bella became the first President of the country.

1863 Battle of Gettysburg ends--The 3-day long battle during the American Civil War was fought between the Union and Confederacy in-and-around the town of Gettysburg, Pennsylvania. Thought to be one of the bloodiest battles of the war - around 50,000 soldiers were lost on both sides – the Battle of Gettysburg marked a key turning point in the conflict. The decisive Union victory led to the retreat of Confederate soldiers from the north.

1844 The Great Auks go extinct--The last known pair of Great Auks, members of a species of flightless birds, were killed off the coast of Iceland at the request of a collector. It is believed that the extinction of these birds was caused by human activities and hunting due to the high demand for their feathers.

Wabaunsee Co. authorities step up patrols after attempted burglaries

ALMA (WIBW) - Wabaunsee County sheriff's officials say they are stepping up patrols following reports of attempted burglaries over the weekend.

The Wabaunsee County Sheriff's Office is currently "conducting an active and aggressive investigation into a series of attempted burglaries that have occurred in rural areas of the county over the weekend," according to a post on the agency's Facebook page.

Wabaunsee County Sheriff Eric Kirsch said he believed it was "prudent and in the best interest of public safety to proactively inform county residents" of the attempted thefts



In the Facebook post, Kirsch noted that "he attempted burglaries included unauthorized attempts to access rural farmsteads, theft of agricultural equipment left in fields and fuel siphoning. The perpetrators are avoiding main roads in deliberate efforts to target isolated locations.d"

Kirsch asked Wabaunsee County residents to notify the sheriff's office of "any suspicious vehicles idling in unusual places, or any unfamiliar foot traffic in the area."

Kirsh added that "our deputies are actively patrolling affected areas and are working diligently to identify and apprehend the suspects."

Of particular note, Kirsch said, the sheriff's office urged all residents, particularly those in rural and working agricultural areas, to secure vehicles; valuables; outbuildings; fuel stores; machinery; and vehicles such as all-terrain vehicles.

Kirsch advised area residents to stay vigilant and to trust their "gut."

Wichita State student, League 42 coach among 8 killed in Mexico crash

WICHITA (KAKE) - A Wichita couple was among eight people killed in a crash while on a family vacation in Mexico.

Orlando Flores, a recent graduate of Wichita North High School and current youth baseball coach at League 42, died in the crash alongside his girlfriend, Nuvia Castillo, a student at Wichita State University. Castillo was studying nursing, according to Wichita State University's student newspaper, The Sunflower.

Dulce, a close friend of the Castillo family, set up a GoFundMe and shared that during their drive back from Mazatlán to Zacatecas, the Castillos were hit by a semi-truck and killed. Juan, Sabina, Nuvia, Raúl, and Hortencia Castillo, as well as Diana Lisbeth López Quiróz and Orlando Flores, lost their lives in the accident, according to the GoFund-

The GoFundMe calls the crash "an immense loss," and any donation amount would be appreciated.

Arrested for attempted second-degree murder

JACKSON ČOUNTY (WIBW) -A Mayetta woman was arrested on multiple charges following an early morning incident on June 30.

According to Sheriff Tim Morse, the Jackson County Sheriff's Office received a report of a person with a gun threatening people and a report of multiple gunshots at 18199 S. Road on Monday around 3:30 a.m.

Deputies responded to the location and, while on scene, discovered that a pickup truck at the residence was used in running down a man on a motorcycle, causing injuries to the man. It was reported that a second vehicle was struck by the truck.

Three juveniles who were found staying at the residence were placed into police protective custody.

Chellcie Lynn Sparks, 37, of Mayetta was arrested and booked into the Jackson County Jail for attempted second-degree murder, aggravated battery, aggravated assault, criminal threat, criminal restraint, aggravated endangering a child, possession of methamphetamine, and possession of drug paraphernalia.
