when an infected person talks, sneezes or coughs. People who are not vaccinated or lack immunity are especially at risk of becoming infected. Symptoms of measles typically begin with a high fever, cough, runny nose, and red, watery eyes. Three to five

days after symptoms begin, a skin rash develops and usually starts on the face and spreads down to the neck, trunk, arms and legs. During a measles outbreak, about one in five children who get sick will need hospital care, and one in 20 will develop pneumonia. Rarely, measles can lead to swelling of the brain and death. It can also cause pregnancy complications, such as premature birth

and babies with low birth weight. Providers should report any suspected cases to the KDHE Epidemiology Hotline at 877-427-7317, option 5, immediately, preferably while the patient is still with the provider.

Montana, Iowa, Kansas, Nebraska, South Dakota, and Wyoming.

Its electric utility will serve approximately 700,000 customers and operate approximately 38,000 miles of electric lines and approximately 2.9 gigawatts of owned generation capacity

fueled by a mix of thermal, hydro, and wind.

Its natural gas utility will serve approximately 1.4 million customers and operate approximately 59,000 miles of natural gas lines. Over time, this increased scale is expected to drive operating and cost efficiencies across the combined enterprise.

The combined company will be headquartered in Rapid City,

S.D., and will maintain a strong operational and leadership presence throughout the combined service territory, consistent with the practices of the companies prior to closing.

The combined company will have a new name and ticker symbol, to be determined prior to the close of the transaction. The operating companies are expected to maintain their current names at transaction closing.
