## Road becomes minimum maintenance

After a public hearing Monday, the Ellsworth County Commission approved Resolution 2025-R-06, declaring certain roads in Ellsworth County as minimum maintenance roads, specifically 27th Road from K-140 Highway to Avenue K and Avenue J from K-140 Highway to 27th Road.

The request was made three weeks ago by Carneiro Township Trustee Kelly Cikanek.

It was noted that since the nearby bridge on K-141 Highway is temporarily closed for construction, drivers have been taking a detour to 27th Road and Avenue J, parts of which are impassible after a rainfall.

Commissioner Shawn Thomas said he has received six telephone calls from individuals in that area.

“I received quite a few pictures of the condition of it (the road),” he said. “And pictures of some of the tow bills that some of the individuals received. I think one was like \$900 and one was more than that.”

Thomas said he also listened to the concerns of some of the individuals who helped the driv-

ers who were stuck.

“All of us have been out to the road,” he said. “In dry conditions, it’s not great.”

Thomas said in his opinion, the minimal maintenance is the best solution from a cost prohibitive standpoint.

“I think that’s what I would do,” Commission Chairman Greg Bender added, noting before the bridge construction, very few drivers traveled the road.

Gretchen Griffith-Hughes said during the last township board meeting of 2024, she recommended using extra money to repair the road instead of putting it into the equipment fund.

She noted the township is allowed to put up to 25 percent of their income into the equipment fund, which left \$11,883.

The board voted to move those funds into the equipment fund (an estimated \$50,000 over the last five years).

Hughes said these funds should have gone to repair of the roads, which have been known to be bad for a decade or more.

“I feel our tax dollars are not being utilized, as expenditures should be based on duties described in KSA 80-301,” she said. “So if these roads are to be assessed as low maintenance, then it is my

belief that our taxes should be reduced accordingly.”

“The board’s responsibility is proper care and management of all property and roads,” Michelle Vanek said. “They were elected to manage the township with the money that is given for this reason.”

Vanek noted the road has been minimum maintenance.

“That’s why we’re in the position that we are in,” she said.

Vanek said the right thing to have been done was for the township board to notify the community of the issues and call a special meeting.

“Prior to the meeting,

the resolution had already been drafted and ready to be signed by board members, without consideration for the taxpayer,” she said.

Cikanek said maintenance of the road is not going to change.

“We’re not planning to reduce maintenance on that road,” he said. “We’re trying to solve the problem.”

Cikanek said the signs to be installed would say “Low Maintenance: Travel at Your Own Risk.”

This lets people be aware the road is in bad condition when wet.

“All I know is cars are
