Bridge construction is still underway on Highway 2 that has increased traffic on the ruck march route. Motorists that drive the route should remain diligent in looking for participants of the event. "It's Saturday morning and I don't see a ton of traffic on that road on that day, but there's going to be more than usual," McNally stated.

For those wishing to participate, there is a registration form on the Stateline Memorial Ruck March Facebook event page or you can call (620)213-0456 to register. There is a \$15 entry fee for the event that will be donated to help support the Sons of the American Legion in Hardtner. Payment can be made through the event registration page or at registration the morning of the event. T-shirts for an additional \$20, which can be purchased online by following a link in the registration form. A portion of the t-shirt sales will also be donated to the American Legion fund.

"So it's nice for the Legion to make a little bit of money from it, you know, but people are also very generous at lunch, too," McNally shared. "We put a jar out and people are incredibly generous every time we do that as well."

Although there will be some water provided, participants need to bring whatever water they require for the walk with them. "We'll have water and Gatorade along the route," McNally said. "I suggest people bring their own stuff to be as self-sufficient and self-sustaining as possible, but, we'll have it available."

McNally wanted to emphasize to those who are interested, but may be skeptical of making the entire distance, that any distance is fine. "Come out and challenge yourself and see what you can do," he said. "One woman made it halfway [last year]. I saw her a few weeks ago and she's been training up for it. There's some folks around town, same way. If it wasn't for those folks that ask me about it and tell me that they're training, it would be hard to keep this thing going. Now that I know people are excited about it and are training for it throughout the year, I'm going to keep it going. The more

folks we can get, the easier it is for me to be motivated to keep it up."

Last year 18 people participated and around 500 pounds of food were donated, bringing the grand total to over 2,000 pounds since McNally began the Stateline Memorial Ruck March. Those donating need to check for expiration dates. Anything outdated cannot be donated.

In the event of inclement weather, McNally plans to get word out via Facebook.

If there are people that can't walk at all but would like to donate food, it can be dropped off the day of the event at the legion in Hardtner. Community members can also donate to the food banks that are located in Kiowa or Medicine Lodge.

There is also a need for side-by-sides that can travel the route to help where needed. "If anybody has a sideby-side or a chase vehicle, if they want to join us on the route, they're welcome to help us out," he said. "I'm wanting to have a few more this year because of the detour. I'm wanting to have one or two up front and then we always have one or two driving back and forth, just checking up on people. Anybody that would like to do that, they're more than welcome to join us. If they would like to just show up at the community building there in Kiowa the day of, that'd be fine. We'll find a spot for them.'

Department of Health and Environment Public Notice Gold Bond Building Products, LLC. Application to Expand an Industrial Landfill

The Kansas Department of Health and Environment (KDHE) has received an application to expand the Gold Bond Building Products, LLC industrial landfill. The permit modification will increase that landfill's permitted disposal area from 15.01 acres to 33.75 acres. The expansion's effect will be to increase the site's disposal capacity from about 775,408 cubic yards to about 1,290,606 cubic yards. The proposed landfill expansion would be constructed and operated in conformance with state solid waste regulations and accept only industrial waste as defined by Kansas Statutes and generated by Gold Bond Building Products, LLC. The proposed landfill expansion site is located at 20672 NW White Sands, Sun City, KS.

The Barber County Commissioners have certified that the landfill is consistent with the county's solid waste management plan and local land use restrictions or zoning. KDHE has reviewed the application and found it to be in conformance with the state solid waste statutes and regulations.

KDHE is today providing public notice of the intent to approve the proposed landfill expansion. However, a final decision to approve the expansion has not been made, and KDHE will consider information gathered during the public comment period before making a final decision. A copy of the administrative record which includes the permit application, engineering drawings, draft permit, and other information with respect to this permit action will be available for public review from May 1, 2025 through June 1, 2025 during normal business hours at the following locations:

Additionally, the permit application form with primary application information is available for public viewing via the Internet at http://www.kdheks.gov/waste. Anyone wishing to comment on the landfill's permit modification should submit written statements postmarked no later than June 1, 2025 to Joseph Hacker at 1000 SW Jackson, Suite 320 Topeka KS 66612, by fax at (785) 559-4253, or by e-mail to joseph.hacker@ks.gov. Mailed comments postmarked prior to June 1, 2025 and received within one week thereafter will also be considered.

After consideration of all written comments received during the public notice period, KDHE will make a final decision on whether to issue the permit. Notice of the decision will be given to the applicant, anyone who submitted written comments during the comment period, and those who requested notice of the final permit decision.
