AN ORDINANCE RELEASING AND VACATING A PORTION OF THE UTILITY RIGHT OF WAY OF KIOWA DISTRICT HOSPITAL FIRST ADDITION, KIOWA, KANSAS

WHEREAS, the governing body of the City of Kiowa shall have power pursuant to K.S.A. 12-101 et. seq to release or vacate the easement or right held for the purpose of public utility;

WHEREAS, the City of Kiowa desires to release and vacate a portion of the utility right of way below described:

That certain 20' utility easement located along the South Line of Lot 1 in Block 1 of the Kiowa District Hospital First Addition to the City of Kiowa, bounded on the east end of said easement by South Seventh Street and the west end of said easement by South Fourth Street a/k/a Kansas Highway K-8;
