Dear Readers.

Out of these 50 United States, Kansas ranks 35th in overall population with just shy of 3 million citizens. So, some of you might find it surprising we rank 5th in overall miles of what is consider "drivable" roadway. Sources vary (widely) but a general consensus is that out of our 286,606 miles of road about 98,000 of those miles are unpaved. That's a lot of dirt and gravel. And I have been down much of it, whether intentionally or not. Many of you already know of my propensity to take the roads less traveled when going from A to B across the state, finding myself wandering like a tourist through undiscovered country. And on one of these latest forays I began to wonder just why these roads were placed where they are, besides the obvious.

We all know all roads are simply connections between cities and towns and fields and, most of all, people. But the genesis, the initial layout of these byways goes way back even before settlers began to arrive and "settle" a couple of hundred years ago. If you take a look at any road map you can see patterns developing, and they are fascinating. And it all starts, as all things started in the country, with the movement of Native Americans. When I read about pioneers "blazing trails" across the state it isn't hard to fathom that most of those trails were already blazed by the migratory, trade and daily living routes establish by our Native tribespeople. They did the heavy lifting, which was to establish routes along waterways but also thousands of cross-country trails forged to get them where they wanted to be, when they wanted to be there. So, it is only logical that those who came to follow used these avenues. They widened them, of course, and paved them with a variety of aggregates and lumber, river rock and gravel over the decades.

A Scotsman named John Loudon McAdam invented a system of road-laying involving strata upon strata of various sizes and densities of crushed stone that would not compress easily under wagon wheels and shed water onto what we now call "shoulders. Hence, the Macadam method of road building. This was mainly used in urban or interurban high traffic areas and did little good to those hearty explorers venturing West on the Santa Fe or Oregon trails in heavy Conestogas and Prairie Schooner wagons. There were other wagons of course, the Bullwhacker or Muleskinner, usually drawn by oxen who required less water along these arid trails than did horses.

In any case, long before the advent of the railroad and automobile there were plenty of ways to get around Kansas, opening every corner, every nook and cranny of our 82,278 square miles to homesteading, development and commerce. And, as they say, this is just the tip of the iceberg because in next week's column we are all going to take a road trip and explore how other modes of transportation shaped the very roads you and I travel daily.
