Verifying publication is difficult-toimpossible on the web. That's why the courts subject digital evidence to far greater scrutiny than evidence published in newspapers

Those who are older than 65 or who have lower incomes or lack high-school diplomas are also cut off from the internet in far higher numbers than the average.

Moreover, the real digital divide for public notice is growing
