minutes. Commissioner Knoll seconded the motion. The motion passed 3-0.

Graham County Community Development- Jason Luginbill Jason informed the commissioners that he is currently working on the Pitch Your Porch Grant, working with Michael Abbott on the KDHE grant for the benches at Trexler Lake, and continuing his work on the housing project.

Graham County Road & Bridge-Wayne Pfeifer Wayne informed the commissioners that preparations are underway for mowing around the cemeteries in preparation for Memorial Day, as well as around Antelope and Trexler Lakes. He also inquired about what fund the grader and pickup tracking device bills will be coming from, as he is starting to prepare his budget for next year. The commissioners clarified that these expenses would come from the county general fund. Additionally, Wayne shared that he spoke with John Deere about getting quotes for graders and is awaiting figures from a salesman. He also mentioned receiving quotes from three dealerships for new mowers.

Conservation District-Tanner Kubick, Ted Nighswonger, and Terri McNeal from the Conservation District presented their budget request for the upcoming year. They requested the same budget amount as last year. Commissioner Knoll moved to approve the budget for the Conservation District, and Commissioner Irby seconded the motion. The motion passed 3-0.

Nicodemus National Historical Park-Cassie Branstetter Cassie informed the commissioners that preparations are beginning for the 150th Celebration of Nicodemus in 2027, followed by the 150th Annual Homecoming Celebration in 2028. She shared that they are aiming to make these events significant and have already started the preparations. Cassie assured the commissioners that they would stay in touch if there was anything they needed from the commissioners.

Health & Wellness Committee- Crystal Behanna and Kristen Wise Kristen informed the commissioners that the Health Fair was a success, raising over \$1,000, which will go towards their Health and Wellness Fund. The Community Foundation will match the amount. Their action plan was approved, and their next event will be a Baby Shower for expecting or new parents. At this event, they plan to give away car seats, pack and plays, and home safety kits provided by the Attorney General. They will provide more details on this on a later date.

Commissioner Knoll moved to adjourn the meeting. Commissioner Nelson seconded it. Motion passed 3-0.
