### Memories from yesteryear

The Settling of

**Stevens County** Everything seemed to be going from bad to worse after the trial at Paris. The people of Stevens County were still on opposite sides, and hard feelings were apparent. All those who took sides endangered their own lives and the lives of their families. Stevens County was not a place for raising a family or even living at that time. So, in the fall of 1890, Mr. Trent and I sold the bank, the lot the bank was on and the corner lot adjoining on the north, my residence on the avenue, and some deeded and school land to J. W. Newcomb of Wichita who claimed to have one hundred head of whitefaced steers and as good a home as there was in Wichita. The home part I knew, for I was in it.

The spring of 1891, our household goods were shipped from Hugoton to Eldorado. In June, Mrs. James and I were subpoenaed to go to Hugoton as witnesses on a federal case. We arrived in Hugoton June 22, 1891, in time for court

that day.

JUNE 23, 1891—Court convened and soon adjourned for the preliminaries. Sam Wood had been subpoenaed on his arson case as previously he had written to farmer friends living east of Hugoton to go to Hugoton and burn the town on a certain day when all the people were at a horse show a mile away. These two men afterward fell out with Sam, then they brought the letter in and gave it to W. O'Conner the prosecuting attorney. He brought suit against Wood.

Sam came in a buggy with Mrs. Wood and Mrs. Carpenter on each side of him so that no one could shoot him without killing a woman as they came through the sandhills.

Mr. Humphrey and I were

still in the courtroom talking when Wood came in and leafed over the dockets. He stayed a few minutes and then started to return to the buggy. He passed Jim Brennan, who was loafing in the doorway, and went out the door. Two or three reports from a revolver rang out clearly; all that was in the

room rushed out to see what it, but no man (with a big was going on. Mrs Carpenter was yelling, "Oh, they have killed Colonel Wood." Mrs. Wood was screaming and running after her husband.

After Colonel Wood received the bullets, he ran along the side and the end of the church or courthouse and fell dead, his wife hovering over him as she had followed him as he tried to escape the shots.

Mr. Humphrey and I decided it wasn't any place for us so we started for town. There was Sheriff Cann trying to arrest Jim, revolver in hand but not raised yet. Brennan had his two selfcocking revolvers up and pointing at Cann, saying, "If you raise that gun you are a dead man." Cann could have killed Brennan, but he would have died too, and he knew it so he used good judgment by not raising his gun or shooting.

The stalemate went on for a few minutes, Cann advancing toward Brennan saying, "You have killed Sam Wood and must be arrested." Jim Brennan replying, "I killed him and I am proud of oath) can live and take me with a gun in his hand."

Jim Brennan was deputy sheriff of Morton County, and about this time his own sheriff came up and pulled off his belt containing his revolvers and threw them down on the ground and walked up to Jim Brennan and asked him to surrender. Jim said, "Alright, but no G..D.. man can take me with a revolver in hand and live." The Morton County sheriff turned Brennan over to Mr. Aurell, the constable.

All of the south side men seemed to be glad to see Wood dead, and all the north side men were ready to fight because he had been killed. We realized the situation was a powder keg ready to go off so we bulled for Liberal as fast as we could and then back to Eldorado.

Sheriff Cann Brennan to Liberal and from there east to another county seat so no harm could come to him. As they went to and from Liberal to Jim's trial, no one dared attack Cann and Jim for they were both crack shots and well armed. The

court tried for days and could not get an impartial jury for all north and south side men had made up their minds so again a man who had killed went free.

Years afterward, when Wood's little boy grew to be a man, he made an effort to bring Jim Brennan back from Oklahoma and have him tried for the old offense. But even after all those years, the old feelings were still there, and the south side Stevens County men still protested so much that the state of Oklahoma refused to give him up. He died a natural death in Oklahoma.

**ROBERT O. JAMES**


