mural and helped her write the grant to get the funding for the project. She also credited Faust for overseeing the completion of the grant process.

She thanked Brick Mob artist Chris Garcia of Wichita who designed and painted the mural. M&M Pipeline power washed the south side of the H&R Block building where the mural is displayed with the approval of building owner, Stewart Miller.

Miller also assisted with the installation of the shaker which was built by Miles Morton of Sterling along with welder Mike Knowles. EBH Engineering ensured safety guidelines were followed during construction of the shaker.

The mural was funded by a Kansas Arts Commission and National Endowment for the Arts grant and a partnership between Lyons Salt and Compass Minerals

She also thanked Lyons Parks Director Matt Detmer and William Mc-Gaughey for landscaping the park. She said other ideas for future growth and development of the park that will help utilize it as a way to bring people and tax dollars to the community are under consideration.

She finished by recognizing donors to the project: Lyons Endowment Association; Lyons Chamber of Commerce; Southern Star, solar bench; Lyons Rotary Club, Little Free Library; and Luke Fall, and Crystal Fall for donating the property.
