# Moran sponsors NWS bill

**U.S. Senators Jerry** Moran, Kansas Republican, and Gary Peters, Michigan Democrat, have introduced the Federal Operational Resilience in **Emergency Conditions** and Storm Tracking (FORECAST) Act that would exempt certain National Weather Service employees from any executive order or memorandum imposing a hiring freeze.

Both Moran and Peters are members of the Senate Appropriations Subcommittee on Commerce, Justice, Science and Related Agencies.

The NWS roles included in the exemption include positions responsible for issuing weather and flood warnings, maintaining critical observational equipment and protecting life and property. This legislation requires the secretary of commerce to submit a report after one year of enactment on staffing levels at the NWS for those covered positions. "Staffing National Weather Service offices, particularly in rural parts of the country, is a constant challenge, and recent staffing shortages have led to some offices, including in Kansas, being unable to provide 24/7 weather forecasting," Moran said. "As we work to install new technology and modernize the National Weather Service, it is important the NWS is able to continuously fill critical public safety roles as they become vacant to make certain communities across the country receive timely, accurate weather data." Moran recently secured a national exemption from the federal hiring freeze to enable the NWS to hire meteorologists and weather forecasters. As employees retired or left for other jobs, the Goodland NWS office had to cease night-time forecasting in May due to staffing shortages. While Goodland NWS works to fill these vacancies, the office will be temporarily staffed by a rotation of NWS employees from other offices to return to 24/7 operations June 15.

# **CITY ORDINANCE**

# Ordinance No. 25-01

An Ordinance amending the municipal code of the city of Beattie, Kansas, requiring written approval by the city council for any manufactured or modular home to be moved into the city limits.

WHEREAS, it is deemed in the best interest of the City of Beattie to regulate said projects the following shall apply. BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BEATTIE,

# KS:

Written approval by the city council will be required of all manufactured and modular homes prior to their movement into the City Limits.

The following standards shall be met for a residential design manufactured and modular home

- 1. A pitched roof with customary residential roofing material.
- 2. Customary residential siding materials.
- 3. No less than 22 feet in width unless approved by the city council.

4. Unit must be less than 10 years old unless approved by the city. 5. A permanent (poured in place or filled/reinforced concrete block) perimeter foundation.

- 6. Not within 10 feet of a city water or sewer main
- 7. Not within a reasonable distance from electrical lines.
- 8. Shall not be placed in city streets or alley right of way.
- 9. All permanent construction shall be at least 5 feet from the landowner's property line.

10. Water & sewer service connection, cost of a pit, taps, digging, supplies, pipe will be paid by the customer on all new or existing meters.

11. All existing water meters needing to be moved at the request of a resident will be done only with the city council's approval and at the resident's expense

12. Any resident wanting a new water or sewer tap will be charged according to city ordinances, and all costs for breaking and repair of the city street will be charged to the resident.

13. Not allowed to be used as a storage unit. If utility services are off for 3 consecutive months, then the home must be removed from the city limits unless special permission is granted by the city council.

# DEFINITIONS

Manufactured Home: A structure which bears the HUD "seal of approval" and is subject to the federal manufactured home construction and safety standards established pursuant to 42 U.S.C 5403, and constructed on or after lune 15, 1976

#### Residential-Design Manufactured Home: A manufactured home that satisfies the following additional criteria:

1. The manufactured home has minimum dimensions of 22 feet in width and 40 feet in length.

2. The pitch of the roof of the manufactured home has a minimum vertical rise of three feet for each 12 feet of horizontal run and the roof is finished with a type of shingle that is commonly used in standard residential construction in

# **Technical assistance** grant received

A \$210,000 Economic Development Administration technical assistance planning grant has been awarded to the North Central Regional Planning Commission in Beloit. Marshall County is a member of the regional planning commission.

"NCRP provides invaluable planning and technical assistance to its member communities," said U.S. Sen. Roger Marshall, Kansas Republican. "For small, rural communities, planning assistance is essential to helping the communities position themselves for future funding opportunities and financially responsible infrastructure investments." The North Central Regional Planning Commission serves 12 counties in north central Kansas, including Marshall County, through centralized planning and technical assistance. The regional planning organization works in partnership with multiple federal agencies including EDA, USDA and U.S. Department of Transportation to implement grants and technical assistance.

3. All roof structures shall provide an eave projection of no less than six inches, which may include a gutter.

4. The exterior siding consists of vinyl or metal horizontal lap siding (whose reflectivity does not exceed that of gloss white paint), wood, or hardboard, comparable in composition, appearance and durability to the exterior siding commonly used in standard residential construction in the city.

5. The manufactured home set up in accordance with the recommended installation procedures of the manufacturer and the standards set by the National Conference of States on Building Codes and Standards and published in "Manufactured Home Installations, 198711 (NCS BCS A225.1), and a continuous, permanent masonry foundation or masonry curtain wall not pierced except for required ventilation and access, is installed under the perimeter of the manufactured home; and

6. Stairs, porches, entrance platforms, ramps and other means of entrance and exit to and from the home shall be installed or constructed in accordance with the standards set by the building code and attached firmly to the primary structure and anchored securely to the ground; and it is the purpose of these criteria to ensure that a Residential Design-Manufactured Home, when installed, shall have substantially the appearance of an on-site, conventionally built, single-family dwelling.

Modular Home: A manufactured residential structure built to a nationally recognized and accepted construction standard published by the Building Officials Conference of America (BOCA) or the International Conference of Building Officials (ICBO) and the unit is inspected and certified at the factory that it meets said standard. A modular home shall have exterior building materials and appearance similar to the customary single-family structures in the neighborhood and shall be permanently situated on a concrete foundation. If an approved manufactured or modular home does not follow the above guidelines, then utility services will not be connected by the city or the city utilities already in service may be disconnected. Legal implications may apply, and the Beattie City Council may assess fines up to \$500.

ADOPTED by the governing body of the City of Beattie, Kansas on June 4, 2025 and approved and signed by the Mayor.
