USD 303 to host town hall on April 24 to discuss proposed school bond

for May 6, the USD 303 Facilities Steering Committee invites all community members to a Town Hall Meeting on Thursday, April 24, from 7:00 to 8:00 p.m. at the Ness City Junior/Senior High School auditorium.

The purpose of the meeting is to provide clear, factual information about the \$24 million bond proposal—and to give voters the opportunity to ask questions, share concerns, and better understand what's at stake.

"We understand that this is a big decision," said Weston Vogel, committee member and parent. "Some people may be thinking, 'Isn't this too much?' or 'Why now?'—those are fair questions. This meeting is where we talk about all of it, openly and honestly."

Topics to be covered include:

- What the bond includes: From FEMA-grade storm shelters and secure building entrances to essential HVAC, electrical, and roofing upgrades.
 - Why it's needed now: With aging infrastructure, ris-

ing repair costs, and safety concerns, the proposed bond project tackles immediate needs and prepares the district for the next generation.

- How it affects taxpayers: Examples will be shared to show the monthly cost for typical homes, farms, and businesses.
- How the proposal was developed: Learn about the year-long collaborative process involving school leadership, local citizens, and construction professionals.
- What it means for the future: A look at how the proposed changes support student learning, community safety, economic development, and local pride.

Community members are encouraged to attend, ask questions, and be part of the conversation about the future of Ness City schools. This is a chance to hear the facts directly, share your perspective, and make an informed decision ahead of the May 6 election.

Measles outbreak nearby

Dr. Harley Calvin, Ness County Health Department Medical Director, wants Ness Countians to know that we are a bordering county to a Measles case! With that being said the following is want you need to know.

Cases in Kansas

Due to the highly contagious nature of measles, additional cases are likely to occur in the outbreak area in Kansas and in surrounding counties especially among those that are unvaccinated. Learn More About Measles

Measles is caused by a virus that spreads easily from person to person. It is an airborne disease, meaning it spreads through the air when an infected person breathes, coughs, sneezes, or talks. The virus can stay alive in the air and on surfaces for up to two hours. Thankfully, two doses of Measles, Mumps and Rubella (MMR) vaccine can almost always prevent mea-

Measles, also called rubeola, causes a rash, fever, chills, body aches, and headache. Common complications of measles include ear infections, pneumonia, croup, and diarrhea. But measles is more than just a rash—it can lead to serious problems like brain inflammation, pneumonia, and other infections. Even healthy children can become seriously ill and may need to be hospitalized.

Measles can be life-threatening; 1 to 3 in 1,000 children may die from lung or brain complications. Young children, pregnant women, and people with weakened immune systems are at greatest risk for se-

vere measles. A person with measles can spread the rash appears to 4 days after. Measles is a highly infectious disease. On average, one infected person can spread measles to 12 to 18 unvaccinated people.

Know the Symptoms

First you may experience..







Red and watery



Runny Nose

Two or three days later you'll start to see..

Spots inside the mouth



Then, three to five days later you'll notice..

The measles rash, which typically begins at the hairline and spreads down the chest and back, which is a key symptom.



If you think you have been exposed or are experiencing symptoms of measles, please call your health care provider or your local health department at the number above and tell them about being in contact with someone that had measles.

If you want to get the measles vaccine to protect yourself and your community, disease to others from 4 days before the call your local health department for information on accessing the vaccine at the number above.
