You, and each of you, are hereby notified that Stanlee Oil LLC has filed an application to commence the disposal of saltwater into the Arbuckle formation at the Mars #1-4 SWD, located 1783' FNL & 335' FEL (SE/4 NE/4) of Section 4, Township 20 South, Range 23 West, Ness County, Kansas, with a maximum operating pressure of 250 psig and a maximum injection rate of 2,000 bbls per day.

Any persons who object to or protest this application shall be required to file their objections or protests with the Conservation Division of the State Corporation Commission of the State of Kansas within thirty (30) days from the date of this publication. These protests shall be filed pursuant to Commission regulations and must state specific reasons why granting the application may cause waste, violate correlative rights or pollute the natural resources of the State of Kansas.
