ORDINANCE NO. 1517

**AN ORDINANCE OF THE GOVERN-
ING BODY OF THE CITY OF MARION,
KANSAS AUTHORIZING THE ACQUI-
SITION AND CONSTRUCTION OF
WATER SYSTEM IMPROVEMENTS;
AND AUTHORIZING THE CITY TO IS-
SUE GENERAL OBLIGATION BONDS
TO PAY THE COSTS OF SUCH IM-
PROVEMENTS.**

WHEREAS, the governing body of
the City of Marion, Kansas (the "City")
is authorized under the laws of the
State of Kansas, to own, operate and
maintain a municipal water system
and the City has previously acquired,
constructed and maintains such a mu-
nicipal water system (the "Water Sys-
tem"); and
WHEREAS, said Water System consti-
tutes a "public water supply system"
within the meaning of K.S.A. 65-162a
and the governing body of said city
hereby finds and determines it nec-
essary and advisable to acquire and
construct certain improvements to,
and otherwise reconstruct, improve,
equip, rehabilitate and extend the
Water System, including certain new
water meters, software upgrades, and
water plant improvements within the
City, together with all necessary ap-
purtenances therefor and thereto
(the "Project") at an estimated cost
of \$350,000 plus costs of issuing
bonds; and

WHEREAS, the City is authorized by
K.S.A. 65-162a et seq., as amended
and supplemented, and K.S.A. 10-101
et seq., as amended and supplement-
ed (collectively, the "Act"), to acquire,
construct and install the Project; and

to issue the City's general obligation
bonds for the purpose of paying all
or part of any costs thereof.

NOW, THEREFORE, BE IT ORDAINED BY
THE GOVERNING BODY OF THE CITY
OF MARION, KANSAS:

Section 1. Authorization of Project.
It is hereby found and determined
to be necessary and advisable to ac-
quire, construct and install the Proj-
ect (as defined above) in accordance
with certain plans and specifications
as previously or to be approved by the
governing body of the City or City En-
gineer.

**Section 2. Payment of Project
Costs.** It is hereby authorized, ordered
and directed that the Project be ac-
quired, constructed and installed, all
as hereinbefore described, at a to-
tal estimated cost of not to exceed
Three Hundred Fifty Thousand Dol-
lars (\$350,000) plus the costs of issu-
ing the Bonds. The Project is intend-
ed to be paid from the proceeds of
the City's general obligation bonds
(in one or more series).

**Section 3. General Obligation
Bonds.** It is hereby further autho-
rized, ordered and directed that all
or a portion of the costs of acquiring,
constructing and installing the Proj-
ect shall be paid from the proceeds of
the City's general obligation bonds to
be issued by the City in an amount of
approximately \$350,000 plus costs of
issuing the Bonds.

**Section 4. Authorization of Tempo-
rary Notes.** It is hereby further autho-
rized, ordered and directed that in or-
der to temporarily finance the estimat-
ed costs of the Project until the issu-
ance of the general obligation bonds
as hereinbefore provided, there shall
be issued temporary improvement
notes (the "Notes"), such notes to be
issued from time to time upon subse-
quent resolution or resolutions of the
City which shall provide and set forth
the details of the Notes, including the
fixing of the dates, terms, denomina-
tions, interest rates and maturity dates
(not exceeding four years from the
date of the notes and redeemable at
any time prior to the stated maturity

thereof). Such Notes shall be issued
and provision shall be made therefor
as funds are needed and required for
the orderly construction of the Proj-
ect; and the Mayor and City Clerk are
hereby authorized, ordered and di-
rected to prepare and execute each
of such Notes in accordance with the
terms of this Ordinance and the terms
of the subsequent resolution or reso-
lutions providing for same; and shall
deliver the Notes to persons having
claims against the City in connection
with the improvements, or may sell
the Notes at private or public sale and
apply the proceeds therefrom to the
payment of the actual costs and ex-
penses of the improvements. Any
Notes issued under the authority of
this Section shall be issued under and
will contain a recital that they are is-
sued under the authority of the Act
(as defined above) and shall contain
all other usual and required recitals
and covenants and be in the form
required therefor by said K.S.A. 10-
123; and said Notes may be issued in
combinations with any other tempo-
rary notes being issued by the City as
shall be determined by the governing
body at the time of such issuance to
be in the City's best interest.

Section 5. Reimbursement. The
obligations authorized by this Ordi-
nance are authorized to reimburse
expenditures made by the City 60
days before the date of this Ordinance
and thereafter, as provided in United
States Treasury Regulation § 1.150-2.
Section 6. Effective Date. This Ordi-
nance shall be in full force and take
effect from and after its adoption and
approval, and its publication one time
in the official newspaper of the City.
