AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 3, FIREWORKS, OF THE CITY CODE FOR PALCO, KANSAS.

WHEREAS, THE City of Palco, Kansas, has previously established as Chapter VII. Article 3, Section 7-302 of its City Code, certain laws, rules and works, and it is in the public interest to modify the said chapter and article within the city.

NOW THEREFORE, THE GOVERNING BODY IN AND FOR THE CITY OF PALCO, KANSAS, HEREBY ORDAINS. ESTABLISHES AND AMENDS THE CHAPTER VII. ARTICLE 3, SECTION 7-302 OF THE CITY CODE.

Section 1. DELENQUENT ACCOUNTS. Chapter VII, Article 3 of the City Code, is hereby changed to read as follows:

"7-302. Possession/discharge of Fireworks.

It shall be unlawful for any person to possess, transport, ignite, discharge or cause to be discharged any firework in the City except as specifically permitted in this section.

(a) Consumer fireworks may be discharged within the City of Palco:

(1) Between the hours of 8:00 a.m. and 11:00 p.m. on June 20 through July 7 of each

(b) It shall be unlawful for any person to recklessly or intentionally discharge, ignite or otherwise cause a firework:

(1) To place another person in reasonable apprehension of immediate bodily harm; or

(2) To cause physical contact with another person; or

(3) To deface or damage real or personal property of another person without the consent of any such other person.

(c) Further, it shall be unlawful for any person to possess, ignite or otherwise cause the discharge of any firework that is not a consumer firework or any firework which is prohibited by Federal or state statute or regulation.

Section 2. Effective Date: This ordinance shall take effect on June 1, 2025 and be in force from that date and its publication in the official newspaper.

AN ORDINANCE AMENDING CHAPTER VII, ARTICLE 3, FIREWORKS, OF THE CITY CODE FOR PALCO, KANSAS.

WHEREAS, THE City of Palco, Kansas, has previously established as Chapter VII, Article 3, Section 7-303 of its City Code, certain laws, rules and regulations pertaining to Fireworks, and it is in the public interest to modify the said chapter and article within the

NOW THEREFORE, THE GOVERNING BODY IN AND FOR THE CITY OF PALCO, KANSAS, HEREBY ORDAINS,

ESTABLISHES AND AMENDS THE CHAPTER VII, ARTICLE 3, SECTION 7-303 OF THE CITY CODE.

Section 1. FIRE. Chapter VII, Article 3 of the City Code, is hereby changed to read as follows:

Sale of Fireworks. "7-303. It shall be unlawful for any person to sell, hold for sale, or offer for sale at retail, any fireworks in the city unless such mit from the city as a retailer. The deadline for obtaining a permit for sale of fireworks will be the June Council Meeting to be held in the City of Palco, Kansas. The City Council has the right to refuse any and all permit applications presented to them. The sale of fireworks shall be during the period of June 20 through July 7 of each

year. Any person desiring to sell or offer for sale any permissible fireworks as a retailer shall make an application to the city clerk for a permit authorizing the same. Such application shall include the following information and such additional information as the fire chief shall deem necessary:

(a) The name and residence address of the applicant.

(b) The location of the premises for which the permit is sought. If ownership of premises is different from the applicant, written consent of the owner is required.

(c) When the permit is sought in a temporary structure or facility, the applicant shall provide a legal description of the premises, a description of the structure or facility to be used, and the location of such structure or facility upon the premises. All temporary structures including tents, shall be posted with the approved NFPA 704 placards as described in the Uniform Fire Code. After an inspection of the premises including review by appropriate city agencies such as fire department, developmental services director and consideration of the information contained in the application for a permit, the city council may issue a permit therefore, conditioned upon reasonable safety measures to upon payment of an application fee to the city clerk of fifteen dollars (\$15.00) per individual. The application fee shall be waived for non-profit organizations. Any permit issued under the provisions of this section shall be valid only for the period of June 20 through and including July 7 of the year in which issued and shall be issued in accordance with the Uniform Fire Code article entitled "permits." Persons responsible for the operations of permissible firework stands in which fireworks are stored or handled shall be familiar with safety requirements for the materials being sold, and the appropriate actions necessary in the event of a fire.

Section 2. Effective Date: This ordinance shall take effect on June 1, 2025 and be in force from that date and its publication in the official newspaper. Passed by the Council on
