

1988 CODE OF THE CITY OF MCDONALD, KANSAS, RELATING TO THE PENALTY OF THE NUISANCES GENERAL ORDINANCE

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF MCDONALD, KANSAS:

Section 6-303 of the 1988 code of the City of McDonald, Kansas is hereby amended to read as follows
