

ORDINANCE 910

ORDINANCE AMENDING ORDINANCE NUMBER 714

WHEREAS Atwood has a number of new buildings under construction and some buildings are being demolished and

WHEREAS this work may at times require vehicles with a gross weight of over twenty-four thousand (24,000) pounds to be used, and

WHEREAS there is a need to allow this occasional use,

NOW THEREFORE BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ATWOOD:

SECTION 1. Section 5 of Ordinance 714 is amended to read as follows:

*SECTION 5 STREETS HEAVY TRUCKS CANNOT BE OPERATED ON. It shall be unlawful for any person, business or corporation to operate any bus or tractor with a gross weight of twenty-four thousand (24,000) pounds or more or any tractor, trailer, semi-trailer similar vehicle or part of a vehicle upon any of the following streets or portions thereof, to-wit:*

*Eighth Street from State Street to Grant Street (Highway 36)*

*This section shall not apply to:*

*a. emergency vehicles responding to an emergency,*

*b. To the use of a street or alley by a truck or trailer as herein defined solely for access to adjacent property as is necessary to service that property,*

*c. School buses or*

*d. Vehicles used in construction or demolition of any building or structure on 8<sup>th</sup> street from State Street to Grant Street.*

SECTION 2. Effective Date: This ordinance amending Ordinance 714 shall take effect and be in force from and after its publication in the official city newspaper.


