Public Forum: Adams Brown presented the 2024 audit.

Tabbie made a motion to approve the 3-12-2025 minutes as printed. Luke seconded the motion. 3-0. Motion carried. The special March 18, 2025 meeting minutes were gone over. Tabbie made a motion to approve the minutes as printed. Luke seconded the motion. 3-0. Motion carried.

Lori went over the bills. Mike made a motion to approve the bills. Lisa seconded the motion. 4-0. Motion carried.

Tornado season arrives

Spring brings flowers and (hopefully) rain showers. Unfortunately, it's also the best time of year for tornadoes in Kansas. Kansas averages 95 tornadoes per year but has seen up to 187, with the peak tornado season running from April

I've said it before and I'll say it again: you have to be very unlucky to get hit by a tornado. Most tornados are very narrow and don't last very long. However, the western Kansas town of Grinnell ran out of luck last Sunday. Grinnell is roughly the same size as my hometown of Otis, which makes it feel very real to me. Fortunately, there were no deaths and only bumps and bruises, according to the Gove County Sheriff. Unfortunately, the sheriff estimates only three homes are still standing. The Catholic church lost its roof, but according to one account the ceiling remained intact and candles were still burning. Tornados are finicky and like to make their own rules.

The best thing anyone can do to survive a tornado is to be prepared. Make a plan ahead of time, follow through and don't panic. Immediately seek refuge in the safest location possible, like a basement or interior room and avoid windows and outside walls. I know this will fall on deaf ears, but DON'T go outside to see what's happening or take pictures. In vehicles, abandoning the vehicle and seeking shelter in a sturdy building or low-lying area is crucial.

When you go to shelter, be sure to wear sturdy shoes, not flip flops or sandals, grab your purse or wallet, and take your medications with you. Make sure your cell phone is charged at all times just in case you need it. It may seem like overkill at the time, but it's better to be safe than sorry.

The levels of alerts are Tornado Watch, Tornado Warning and Tornado Emergency. A watch just means tornadoes are possible and stay alert. A warning means tornadoes have been spotted in the area or indicated by weather radar and head to shelter or make sure you can get there in a hurry. A tornado emergency is the National Weather Service's highest alert level. It is issued when a violent tornado has touched down in the watch area. Immediately seek refuge in the safest location possible.

I have lived in Rush County all my life and have never been in a tornado. Bison was hit by a disastrous tornado in 1912, with two deaths reported. La Crosse has been hit twice - once in 1968 and once in 2012 with no deaths either time. There have been smaller tornadoes scattered throughout the county, but these three were the most damaging to communities. My advice is to not live in fear, but don't forget to pay attention. Sometimes common sense is the best weapon you have!
