AN ORDINANCE AMENDING AND RESTATING ORDINANCE 189A PROVIDING FOR THE ASSESSMENT OF MUNICIPAL COURT COSTS
BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF OTIS, KANSAS;

Every person entering a plea of guilty or nolo contendere, or found guilty of a violation of the Ordinances of the City of Otis, Kansas, shall be assessed costs for the administration of justice in the Municipal Court of the City of Otis, Kansas, in the amount of one hundred

fifty dollars (\$150.00) plus the amount specified by the Supreme Court in accordance with K.S.A. 12-4117, plus any other amounts assessed by the Kansas Statutes Annotated.


This Ordinance shall repeal and take the place of any prior ordinance regulating court costs in the Municipal Court of Otis, Kansas.

This ordinance shall be in full force and effect from and after its adoption and publication in the official city newspaper.
