HOME RULE RESOLUTION NO. HR-2025-06
A HOME RULE RESOLUTION AMENDING HOME RULE RESOLUTION NUMBER HR-2015-05 regarding certain portions of the home rule resolution Regulating the Sales and Discharge of Fireworks in the Unincorporated Areas of Rush County Kansas

BE IT RESOLVED BY THE GOVERNING BODY OF THE BOARD OF COUNTY COMMISSIONERS OF THE COUNTY OF RUSH, KANSAS:

Home Rule Resolution number HR-2015-04 was adopted on June 23, 2014 with certain sections of such home rule resolution being Section 4(b) which read as follows:

"Section 4(b): Applicants for permits to sell consumer fireworks may be submitted to the Rush County Clerk's Office during normal business hours. No person shall offer consumer fireworks for sale in the unincorporated area of Rush County before the 27th day of June or after the 4th day of July."

THE ABOVE IS HEREBY AMENDED TO READ AS FOLLOWS:

"Section 4(b): Applicants for permits to sell consumer fireworks may be submitted to the Rush County Clerk's Office during normal business hours. No person shall offer consumer fireworks for sale in the unincorporated area of Rush County before the 20th day of June or after the 7th day of July."

All other portions of said Home Rule Resolution 2015-04 not amended by this amendment shall remain in full force and effect.

PASSED AND APPROVED by the Governing Body of the Board of Rush County Commissioners, this 9th day of June, 2025.

This amending resolution shall take effect upon its passage and publication in the official newspaper of the county.

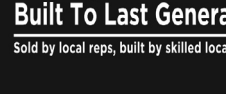

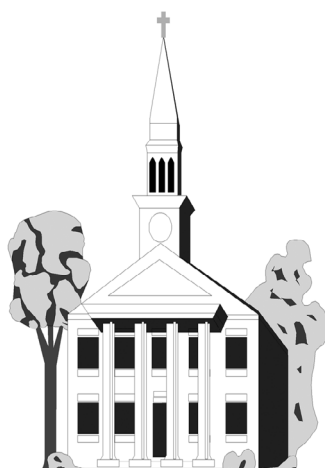
