School officials indicated that nearly all buildings have been thoroughly cleaned and improved during the summer months and that most teaching staff positions for both grade and high school instructors have been filled. La Crosse high school may be forced to start the new term without a home making instructor. Other vacancies exist in the Alexander grade school, district No. 2 rural and district No. 74 rural schools.

Two Bison youths who recently entered the navy have been assigned to a training company and are now in boot camp at the San Diego Naval Training station. They are Robert P. Scheuerman, 19, son of Mr. and Mrs. Herman Scheuerman and Jerry L. Ruff, 18, son of Mr. and Mrs. Le Roy Ruff. Both are graduates of Bison high school and enlisted in the navy July 21 at Wichita.

100 Years Ago

La Crosse Republican August 13, 1925

Quite a severe wind, hail and rain storm struck the north half of the county last night. The hail was particularly bad north of La Crosse a few miles and extended east. Mart Harmon was in town this morning and he said hail fell in wagon loads at his place which was accompanied by a high wind. From Ben Hartman's east to Jake Scheuerman's the hail wrought tremendous damage, ruining the corn, cane and all growing vegetables, knocked out window lights and punched holes in roofs. Hundreds of turkeys and chickens were killed. North and west of town from two to five inches of rain fell. A hard wind accompanied the storm at La Crosse, but no hail fell. The precipitation here amounted to about one inch.

Mgr. Vaughn says he has the best ball team in this part of the state when it comes to small town teams, but his team has no chance of winning from the Chicago White Sox or the Kinsley organization. The game at Kinsley Sunday resulted in a 10 to 0 score in favor of Kinsley. We played good ball, but were outclassed.

COMMISSIONERS MINUTES Monday, August 4, 2025, 9:00 a.m. Chairman Leslie Rogers and Member Richard T. Luft were present. Commissioner Blackburn was unable to attend. Commissioner Luft moved to approve the July 28, 2025 minutes as presented. Commissioner Rogers seconded the motion. Chair called for discussion. Motion carried unani-

The payroll register was reviewed and signed by the board.

A call was received from Judge Bruce Gatterman. Judge Gatterman discussed the current microphones in the courtroom and the need for them to be updated. The microphones are tied to a digital recorder as Rush County has no court reporter.

A call was placed to Katrina Ringler, Deputy State Historic Preservation Officer, to discuss the courthouse window restoration project and financial incentives for the county. Ms. Ringler explained the tax credit program which can provide up to 40% of project expenses back in a tax credit that the county can sell to a financial institution for dollars. The Rush County Courthouse is on the National Register and must follow the State Preservation Law regarding historic preservation of the building.

The Road and Bridge weekly report was presented for review. They graded in Alexander, Belle Prairie, Big Timber, Brookdale, Fairview, Garfield, Hampton, La Crosse, Lone Star, Pioneer and Pleasantdale townships. Magnets were utilized in Banner, Belle Prairie, Center and Pleasantdale and the retriever utilized in Belle Prairie. Sand was hauled in Big Timber, La Crosse and Lone Star; millings/dirt hauled in Center; road repairs done in Banner, Garfield and Pioneer; shoulder work done in Pioneer; a culvert cleaned out in La Crosse and barricades placed in Garfield, Pioneer and Pleasantdale. They mowed in Alexander, Big Timber, Center, Hampton, Illinois and Pleasantdale townships. The mechanics worked on grader #24, mower #17 and performed routine maintenance on county equipment.

Correspondence was reviewed.

There being no other business before the board, Commissioner Rogers moved to adjourn at 11:51 a.m. and to meet again in regular session at 9:00 a.m. on Monday, August 11, 2025. Commissioner Luft seconded the motion. Motion carried unanimously.

August meeting dates: 6th and 20th - 2026 Budget Hearing.


Mayor Schroter motioned to approve to pay the bills, Commissioner Sramek seconded the motion. Motion carried - vote 3-0.


