

## -Otis City Council Minutes-

Council members Tabbie McVey, Mike Sharkey, Luke Pechanec, Jody Beckham, and Mayor Jenny Landers were present at the City of Otis Council meeting held August 13, 2025. Employees present were Myron Wagner, Vernon VanPelt, John Landers, and Lori Firebaugh. Absent was Lisa Moeder.

Mayor Jenny Landers called the meeting to order at 6:30 p.m. There was a moment of silence followed by the Pledge of Allegiance.

Public Forum: none.

Jody made a motion to approve the 6-11-2025 minutes as printed. Tabbie seconded the motion. 4-0. Motion carried.

Luke made a motion to approve the 7-16-2025 special meeting minutes as printed. Tabbie seconded. 3-0-1. Motion carried. Jody abstained.

The bills for June and July were discussed. Luke made a motion to approve the bills.

Jody seconded the motion. 4-0. Motion carried.

Myron went over the water reports and noted that levels have been down for the past

wo months. The treasurer's report was gone over.

City Clerk Report: Lori reminded the council that the Maguire quarterly payment was coming up and that the RNR & Budget hearing will be September 10.

Mayor Report: The council discussed reinstating the Public Forum registration process. Jody made a motion to reinstate the registration requirement, with forms due by 3:00 p.m. on the Friday prior to each council meeting. Luke seconded the motion. The motion carried with a 4-0 vote. The council also discussed including a copy of the registration

form in the next water bill.

Correspondence: none.

Old Business: Dog Ordinance 174 – Jody made a motion to change the registration fee to \$7, neutered or spayed to \$4, and replacement tags to \$2. In addition, the motion included amending the current ordinance by incorporating Section 2 from Ordinance No. 134, with the addition of the phrase "within a GPS or wireless fence" to the updated language. Mike seconded the motion. The motion carried with a 4–0 vote.

Porta pots – Jody made a motion to provide two regular portable restrooms for the Back to School Bash, noting that handicap-accessible units are currently difficult to obtain. Tabbie seconded the motion. The motion carried with a 4–0 vote.

Library lights – Luke made a motion to have Jaguar update the lighting in the library. Mike seconded the motion. The motion carried with a 4-0 vote.

New Business: Water Service Requests – The council discussed requests from two residents seeking water service to their properties. Jody made a motion to table the discussion and requested that the first resident be invited to attend the next council meeting to provide a detailed explanation of their plans. Tabbie seconded the motion. The motion carried with a 4–0 vote.

Jody made a motion to proceed with installing a manual water meter after the second resident pays the required meter deposit fee. Tabbie seconded the motion. The motion carried with a 4–0 vote.

The council discussed the Beautification Committee's upcoming plan to repaint the town curbs, and it was suggested that a few loads of road gravel be ordered for the streets. Mike made a motion to order a couple of end-dump loads of road gravel. Luke seconded the motion. The motion passed with a 4-0 vote.

At 8:45 p.m. Jody made a motion to enter executive session to discuss non-elected personnel until 9:00 p.m. Mike seconded the motion. The motion carried 4-0. The Council returned to regular session at 9:00 p.m. No action was taken.

The next meeting will be held on September 10, 2025, at 6:15 p.m. in the Senior Room, beginning with the RNR hearing, followed by the budget hearing, and concluding with the regular council meeting

Jody moved to adjourn. Tabbie seconded. 4-0. Motion carried. The meeting ended at 9:00 p.m.


