A RESOLUTION OF THE CITY OF LIEBENTHAL, KANSAS TO LEVY A PROPERTY TAX RATE EXCEEDING THE REVENUE NEUTRAL RATE;
WHEREAS, the Revenue Neutral Rate for the City of Lieben- thal, Kansas, was calculated as 66.268 mills by the Rush County Clerk; and

WHEREAS, budget proposed by the Govern- ing Body of the City of Lieben- thal, Kansas, will require the levy of a prop- erty tax rate exceeding the Revenue Neutral Rate; and

WHEREAS, the Govern- ing Body held a hearing on September 8, 2025 allowing all inter- ested taxpayers desiring to be heard an opportunity to

give oral testimony; and
WHEREAS, the Govern- ing Body of the City of Lieben- thal, Kansas, having heard tes- timony, still finds it neces- sary to exceed the Revenue Neutral Rate.

NOW, THERE- FORE, BE IT RE- SOLVED BY THE GOVERNING BODY OF THE CITY OF LIEBENTHAL, KANSAS:

The City of Lieben- thal, Kansas, shall levy a property tax rate exceed- ing the Revenue Neutral Rate of 66.268 mills.

This resolution shall take effect and be in force immediately upon its adoption and shall remain in effect until future action is taken by the Governing Body.

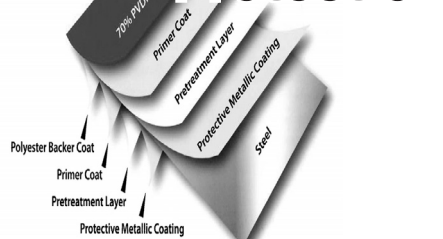
