RESOLUTION NO. 2025-004
A RESOLUTION AUTHORIZING THE COMPLETION OF AN APPLICATION TO THE KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT REGARDING A LOAN FROM THE KANSAS PUBLIC WATER SUPPLY LOAN FUND

WHEREAS, the City of Liebenthal, Kansas (the "City") is a duly incorporated city of the third class organized under the laws of the state of Kansas (the "State") which operates a public water supply and distribution system (the "System"); and

WHEREAS, the City Council (the "Governing Body") of the City has heretofore determined to be in the best needs of the customers of the System to undertake certain modifications and improvements (the "Project") to the System; and

WHEREAS, the pursuant to K.S.A. 65-163c et seq. (the "Act"), the Kansas Department of Health and Environment ("KDHE") administers the Kansas Public Water Supply Loan Fund (the "Fund") from which loans are made to certain qualified Municipalities (as said term is defined in the Act) to finance modification and improvements to public water supply systems; and

WHEREAS, the City has heretofore made an application to KDHE for a loan in an amount not to exceed \$215,000 (the "Loan") to finance the Project; and

WHEREAS, the Governing Body has conducted a public hearing this date on the advisability of proceeding with the completion of the applica-

tion for the Loan and desires to authorize the appropriate officials of the City to accomplish the completion process.

BE IT RESOLVED BY THE GOVERNING BODY OF CITY OF LIEBENTHAL, KANSAS, AS FOLLOWS:

Section 1. Loan Application. The Mayor and City Clerk of the City are hereby authorized to cause to be prepared and to execute a Loan Application, including all attachments thereto (jointly, the "Application"); in substantially the form presented to the Governing Body this date, in order to provide financing for the Project. The Application shall be forwarded to KDHE as soon as possible.

Section 2. Further Proceedings. The Mayor and City Clerk and the other officers and representatives of the City are hereby authorized and directed to take such other action as may be necessary to complete the Application and to coordinate processing of a loan agreement for the Loan (the "Loan Agreement"); provided that the authorization to execute the Loan Agreement shall be subject to further resolution of the Governing Body.

Section 3. Further Authority. This Resolution shall be in full force and effect from and Adopted by the Governing Body of the City of Liebenthal, Kansas on September 30, 2025.

Notice is hereby given that the City of Timken, Kansas is soliciting bids for construction of City of Timken Water System Improvements (Phase 2). The project consists of replacing 2,507 feet of 4" water line, 1,046 feet of 2" water line, 7 gate valves, 5 fire hydrants, 14 water service connections, and various ancillary fittings. The project location is Timken, KS in Rush County. Timken is 7 miles east and 0.25 miles north of the intersection of K-96 HWY and US-183 HWY. Kansas Water Office funds will be utilized to fund this project. All Federal, State, and County regulations must be complied with.

Online Bids (vBids) for the proposed construction will be received by the City of Timken via QuestCDN Virtubid until 3:00 pm local time October 17, 2025. Bids will be presented to the City of Timken Council at the City Building/Fire Station at 7:00 p.m. local time October 20, 2025.

All bids shall be accompanied by a Bid Bond or a Certified or Cashiers check in the amount of 5% of the total bid. Checks or bonds are to be made payable to City of Timken and serve as a guarantee of the sincerity and integrity of the bidder, and shall be forfeited to the City if said proposal or bid is accepted and the bidder fails to execute the contract and file the required statutory and performance bonds as required in the contract documents.

Work will commence no sooner than the date of the signed contract (earliest start date) and no later than April 1, 2026 (late start date). All work shall be completed within 80 working days after the Notice to Proceed.
