NOTICE OF BUDGET HEARING

To: Landowners of Kirwin Irrigation District #1:


You are hereby notified that on the 8th day of July, 2025, at 8:00 p.m. of said day, there will be held at the District Office at the east edge of the city of Gaylord, Kansas, a hearing upon the proposed assessment made by said District against the irrigable land within said District to meet the cost of operation, maintenance and repair of irrigation works to supply water to said District. The board of Directors has levied a \$37.00 assessment against each classified irrigable acre within said District, that this entitles the landowner of such classified irrigable lands the amount of twelve inches of water during the 2026 season, if available.

A hearing will be had thereon at the time and place stated in order to determine if such assessments are just and equitable. Said Board will then and there hear all objections to such assessments and will then make such changes in the same as shall appear to be just and equitable.

A schedule of assessments is now on display in the office of said District at the east edge of Gaylord, Kansas and any interested person may examine the same.


