Home On The Range highlighted during Symphony in the Flint Hills

The Symphony in the Flint Hills celebrated its 20th and final anniversary with a Grand Finale performance on Saturday, June 14th near Emporia, Kansas.

The Peoples Heartland Foundation was invited to represent The Home On The Range Cabin with two presentations Saturday afternoon. Mitch, Tami and El Dean Holthus were invited to speak briefly about The Cabin and Mark McClain was available to answer questions about the Foundation and the recent camto build amphitheater on the prop-

Mitch presented the story of the song "Home on the Range" that included the proving of authorship, and the popularity of the

song. Mitch also added insight on the making of The Home On The Range movie and encouraged the large crowd to learn more about the amphitheater project. El Dean presented the timeline of ownership from Ellen Rust to her revocable Living Trust to the Peoples Heartland Foundation. El Dean also emphasized Ellen's planning, especially in two areas, a sunset clause to make sure the HOR Site had permanent ownership and the retention of nearly 200 acres with the Site to provide income to pay expenses of ownership. This foresight assured donors that 100 % of their gifts would be used to maintain and improve the Site. Tami explained the promotion strategy using Facebook, e-

mails and the homeontherangecabin.com website. Tami also read excerpts from reporter, Andy Raun of the Hastings Tribune who shared the emotions he felt being on the HOR Site when he covered the rededication of the restored Cabin in 2014.Mark, publicly and privately, answered ownership questions.

In addition to the portable Band Shell that provided the stage for the Kansas City Symphony there was a semi-circle of tents which housed food service and information tents with concurrent programs beginning at 2 pm and continued throughout the afternoon.

Drug and Alcohol Council scrutinize laws for purchasing products over seas

was about the alcohol and tobacco laws in Iceland. I will explain some of the laws concerning these products in Great Britain. First of all, the age to purchase alcohol in England is 18 years of age, whereas in the US it is 21. This is a significant difference. One can find alcohol easily available in pubs, restaurants, grocery stores, and convenience stores. Like in the US where beer and other alcoholic beverages are advertised, in GB, all sorts of alcohol products are advertised as well.

The MP is doing so because of the strain on the National Health System to the tune of five billion pounds a year that alcoholic diseases cause. There is, of course, considerable push back by the liquor industry and small businesses.

> Tobacco laws are similar to the US laws. Tobacco is strictly regulated by the government to prevent health issues. No advertising is allowed across all mediums. There is no smoking inside all businesses just like the US. These laws also pertain to vape devises and e-cigarettes. We saw many vape

stores and convenience stores sell these products. As with alcoholic beverages, most businesses require young customers to show an ID. I witnessed a store clerk refuse to sell an alcoholic beverage to a young man who didn't have his ID even when he claimed they sold it to him last week.

Except for the age of 18, the laws concerning alcohol and tobacco are very similar. Both countries are concerned about the long term affects of using and the misuse of these products. The SCDAC is also working to educate the public about the long term affects of these products. As was noted last able grandson contributed to this article.

The Kansas Highway Patrol is investigating a fatal crash that occurred just after 5:00 pm on Wednesday, June 11, 2025 in Cloud County.

One person died in an accident just after 5p.m. Cloud Wednesday in

County. The Kansas Highway Patrol reported a 2013 GMC Acadia driven by Kathy A. Hansen, 72, Smith Center, was eastbound on U.S. 24 just north of 130th

The SUV crossed the center line and collided

with a westbound 2012 Ford Taurus driven by Harry L Hodge, 18, Canandaigua, New York. After impact, the Ford rolled and struck the guard rail, and came to rest in the north ditch.
