The Stockton **Summer Library Program has begun!**



He spent many years fighting his demons and justified his drug habit with his passion for playing guitar by comparing his life choices to big-name performers who are into drugs.

He sought out treatment when his son was born in 2012, but he only stayed sober for a year and ten months. Then he stopped going to meetings and started using again every day within a week.

He continued in this way until he ended up on probation and was in jail six times in one year in different places. While he was on probation, it all came crashing down: he was alienated from his family, his finances were devastated, and he had a warrant out for his arrest. So he had a friend drive him to treatment in O'Neil, Nebraska, on May 4th, 2016, with no intention of staying in treatment. He just wanted to get the law off this back. But while in O'Neil,

With that deadline behind us, the 2025 General Election, which will be held on Tuesday, November 4, is set with the following local citizene to appear on the ballot:

As you can see from the list provided, there were no filings for Damar, Palco, or Zurich City Council, Palco or Woodston Mayor, the Phillips-Rooks Extension District #5 Board, and USD #269, Member District #6.

There will be no need for a Primary Election this fall in Rooks County.

To be eligible to vote in the November 4 election, you must be registered to vote in Rooks County by Tuesday, October 14. If you are unsure of your voting status, contact the Rooks County Clerk's Office at 785-425-6391.

Some important city and municipal election dates for 2025 you might want to note include:

October 14 (Tuesday)—Deadline to register to vote or update your voter registration information to participate in the 2025 general election.

October 15 (Wednesday)-First day advance voting. Advance ballots by mail are transmitted. In-person advance voting may begin.

October 28 (Tuesday)—In-person advance voting must begin.

November 2 (12:00 p.m.)—Deadline for advance in-person voting.

November 4 (Tuesday)—General Election. (All advance ballots by mail must be postmarked by Election Day. and received by Friday, November 7.)

November 17 (Monday)—Last day for county board of canvassers to certify official results.
