Hays childcare searched after report of suspected drug use on premises

HAYS—The Hays Police Department executed a recent search warrant at a childcare in Hays after reports of alleged child endangerment and potential drug use, Hays Police Chief Don Scheibler said. He said the search was part of an ongoing investigation. Scheibler said police officers and officials from the Kansas Department of Health and Environment executed the warrant in the 2500 block of Donald Drive following reports made earlier in the week. Scheibler said an officer sustained minor injuries from a dog bite during the search. No arrests have been made. The police department requested KDHE issue an emergency suspension to close the facility during the ongoing investigation. No names of potential suspects have been released. Scheibler said all parties are considered innocent until proven guilty in a court of law. (Hays Post)

Suspect accused in beating death of man at Kansas home

LYON—Law enforcement are investigating a suspect for alleged murder. Around 7:00 a.m. on Sunday, May 25th, the Lyon County Communications Center received a 9-1-1 call of an unconscious person at the residence in the 200 block of West 10th Avenue in Emporia, according to Police Captain Lisa Hayes, An ambulance and Emporia Police Officers responded and found 62-year-old Raul Rosado Reyes dead inside the residence. Emporia Investigations Division led the investigation and identified 36-year-old Alexei Perez-Ricardo as a primary suspect. Perez-Ricardo was apprehended a short time later in eastern Emporia, questioned, and ultimately booked into the Lyon County Detention Center on requested charges of Murder, Simple Assault and a Weapons Violation. Detectives believe a confrontation between Reyes and Perez-Ricardo took place on Saturday, May 24th. Following the confrontation, Perez-Ricardo is believed to have left the scene on foot to areas in eastern Emporia. He was later seen with a bicycle. Emporia Detectives gathered information from eyewitnesses, home surveillance videos, and cell phones. (Hays Post)

Kansas Originals faces demolition of its building, fears closure

WILSON—After 37 years of being a quirky stop on Interstate 70 where you can find popcorn, wine, Kansas books, t-shirts, or hand-painted limestone, Kansas Originals is facing closure. Kansas Originals owns its building, but not the land on which it sits. The land is owned by Service Oil Company, but has been purchased by a new owner. The new owner has decided to develop the location as a truck stop and is insisting that the Kansas Originals building be demolished or moved. Although the store could be relocated, Marge Lawson, co-founder of the non-profit that created Kansas Originals, said the store is doomed without easy access to I-70. "Through tumultuous months with several owners and waiting for two years through a maze of what might be and assurances from local agencies that we are safe, we received legal notice that we must move out and move or tear our building down by November 30th of this year," Kansas Originals said in a letter to the Hays Post. The Animal Hospital announced sale of Phillipsburg, **Plainville locations**

PHILLIPSBURG/PLAINVILLE—The Animal Hospital at the Crossroads in Phillipsburg and in Plainville stopped offering general appointments and large animal services on May 9th and May 23rd. Dr. Lauren Mack will step back from full-time practice and provide only limited, consultative services going forward. The clinics are intended to be sold to new owners. Mack said in the social media post that it is time to prioritize family as veterinary challenges continue in the region. "The demand of veterinary practice in a rural area is all consuming and although I have taken great pride in the journey, it is simply not sustainable," Mack said. (Hays Post)

Kansas suspects provided unlicensed dental care, made fake ID cards

LYON COUNTY-Law enforcement are investigating eight suspects on multiple allegations after weeks of investigation in southeast Kansas. On April 26th, police attempted to locate a person with an outstanding warrant at an eastern Emporia residence which led to a narcotics investigation, according to a media release from Emporia Police. Officers executed a search warrant and discovered narcotics along with apparent fraudulent documents leading to additional investigations. Officers uncovered a ring of individuals involved in the production, supplying and use of false documents including but not limited to social security cards, identification cards, drivers licenses, and permanent resident cards. One individual under investigation for supplying false documents is alleged to be involved with unlicensed dental offices, uncovered in two homes in eastern and western Emporia. The weeks long investigation by Emporia Patrol Officers yielded eight arrests, more
