Some members couldn't remember which streets had been done recently but Tom assured them it was Sunset's turn. Bruce made a motion to approve the bid. Lori seconded the motion, and it passed unanimously. Tom said he had another quote from Bettis Asphalt that is for half of square footage in the first bid. It was in the amount of 60,075.00. Thomas agreed that he liked it being closer to the bathrooms too. A discussion began about filling in the edges with gravel to prevent the asphalt from crumbling off when people park on the edge. They discussed chip sealing it in the future when it needed it because it would be less expensive for maintenance purposes. Thomas is in favor of biting the bullet and proceeding with this project unless someone has something else to do. There was a question of whether it could be paid for out of capital projects funds. Lynn called Deborah for confirmation that those funds could be used and she said they could. Thomas made a motion to approve the quote. Brian seconded the motion, and it passed 5-0.

DEPARTMENTAL REPORTS SEWER/SOLID WASTE: (Bruce Prater) Bruce said there's a water line on Prairie that needs replaced and he was wondering if it was possible to transfer money out of the sewer department into the water department to get that done. It was decided to discuss it at budget time.

**DEPARTMENT:** WATER (Brian Mayer) Brian said he received a bid for a Generac system with Tom's help. It's \$13,486.00, but Tom wants to order some new water meters first. He said he wants to keep this in mind come budget time.

CITY CLERKS REPORT: Lynn reported the deadline for candidates to file is June 2nd at noon in the County Clerk's


