


## Larry D. Garrison

The group discussed the March 29 Spay/Neuter event where we treated 33 cats. We specifically discussed what worked well, what needed tweaking, and ideas for the next even on June 21st.

- The high school volunteers were extremely helpful!
- Everyone agreed that capping the number of cats accepted for the event at 35 (max of 40) was optimal.

- · Add additional check in tables to space out those helping with check in so people and cats stay together.
- It would be good to make a list of the order of procedures for check-in and throughout the day.
- Schedule volunteers for check-in through noon, and noon through clean-up to have fresh hands and feet at the end of the day.
- Acquire a poster that shows the colors and coat types of cats for easier identification.
- Collect a few additional dark colored blankets to help with cats that wake up "rough".
- Make a few small "quilts' and warm water bottles for kittens that need help regulating body temperature postsurgery.
- Create a Post-op information sheet to send home with participants.

# **Do You Need Conservation** Work on Your Property?

Landowners in Wabaunsee County who wish to implement conservation practices on their land to address soil health, water quality and quantity, wildlife habitat, and other natural resource concerns now is the time to get signed up for the State Cost-Share program.

The Wabaunsee County Conservation District administers two state cost-share programs the Water Resources and the Non-Point Source through the Kansas Department of Agriculture, Division of Conservation. We are having a sign up for the FY-2025 funds during the month of July. The funds will become available July 1, 2025, to the Conservation District to start the contract process. Cost-share funds are not available for conservation work that is already started or completed.

In 2023, the Kansas Department of Agriculture - Division of Conservation moved towards a statewide practice list and payment rate schedule for a more uniform statewide program.

Through the Wabaunsee County Conservation District, you can apply for the following approved conservation practices designed to address water quality and soil erosion controls:

- Access control
- · Cover crops
- · Brush management
- Nutrient management Pasture/hayland planting
- Fence
- · Herbaceous weed control
- Riparian buffers and filter strips
- On-site wastewater system
- Water well decommissioning
- Terraces/restoration

- Critical area planting
- · Wetland creation/enhancement/ restoration
- Windbreak/Shelterbelt establishment/renovation

- · Grade stabilization structure
- Heavy use area protection
- Irrigation system
- · Irrigation water management
- Livestock pipeline
- Mulching
- Ponds/sealilng/lining/compacted soil treatment

- Prescribed grazing
