"I like to get to Southeast Kansas and to get to a variety of businesses," Marshall explained. "This is the only grocery store to stop at on this particular trip."

Prior to leaving Erie, Marshall also shared the following with The Record on his trip through Southeast Kansas. The senator commented on a constant theme from his stops during the week.

"It is all the manufacturing jobs – all the businesses that we ran into and sat down with," he said. "They have seen a big jump the last two or three weeks because of the tariffs going on in foreign countries.

"So everyone is wanting to buy American (products) now. They like the quality of the merchandise as well as the opportunity of long-term stability.

"I think as agriculture still goes to Kansas, I see it as a win getting a farm bill done. I think that is up front and up center and certainly these tariffs have created some controversy as well and people are wanting to know what's the end game going to look like.

"Over and over, the places I go to, I hear them express support for President Trump. They are so happy he secured the border – that he is doing what he said he would do.

"The price of gas has come down. It wasn't too long ago, it was \$4 a gallon. Everywhere across the state, I'm seeing \$2.50, \$2.60 a gallon. Inflation has stabilized. Regulations are being rolled back.

"So really the first time since Covid, I think I sense a message of hope. People are hopeful this country is going back in the

right direction." **Interesting Tidbits** 


#### **About Marshall**

Marshall lived in Great Bend, where he practiced medicine, delivering, by his count, more than 5,000 babies. He and his wife, Laina, have four children.

On Jan. 31, 2018, Marshall was a passenger on a chartered Amtrak train involved in the Crozet, Virginia train crash. He administered first aid and CPR to the injured.

"We had too many missed opportunities," Mattox explained. "We started the game with an error, then we had another throwing error later in the inning and dug ourselves a hole.
