## Girls swim team finishes in third place at league meet to end regular season

The Fort Scott High School cooperative girls' swim team ended its regular season with a third-place finish at the Interleague Girls swim meet Wednesday in Osawatomie.

Head Coach Madeline Martin, who was named League Coach of the Year for 2025, talked about the team's makeup and competitive spirit.

"Our girls have had a great season against some tough competition," Martin said. "They have fought hard for personal best times, continuous improvements, and have shown a great amount of sportsmanship. My favorite part of our team is that these girls are a family. You can't tell that they are from different schools; they cheer for each other, laugh with each other, cry together, and support each other through and through. Fort Scott Tiger swimming will continue to be one family."

Martin explained the scoring and placing at the interleague meet, which she said can be confusing.

"The top 16 finishers earn points for the team with the top eight earning a medal," she said. "Only one relay can count for points per each relay event and only three swimmers per team per event can count for points. So, some girls earned points even though they may have finished 18th or 19th."

Martin said this relay allows swimmers from other schools to join "so they could have the opportunity to swim – a very cool thing we do in our league."

## Tigers, Lady Tigers finish regular season with sweep of Chanute

The Fort Scott High School Tiger baseball and softball teams ended their regular seasons with a sweep of the Chanute Blue Comets Thursday in Fort Scott.

The Tiger baseball team (23-3) earned a 12-11 walk-off win while the Lady Tigers (21-5) notched a 6-1 victory. Both teams will enter Class 4A regional play, which begins Monday.

Lennox Vann's RBI single in the bottom of the seventh broke an 11-11 tie and secured the win for the Tigers. The Tigers collected 12 hits and the Blue Comets

tallied 11 in the offensive contest.

In the first, the Tigers grabbed an early lead on a two-run double by Colton Rogers, two runs that scored on errors and a run on a tag-up by Aidan Stoughton.

Vann and Chayden Clayton knocked in two runs on groundouts in the second.

The Blue Comets retaliated in the fourth with six runs on two hits and added five runs on six hits in the sixth to take an 11-9 lead. Alijah Christy batted in two runs on a single in the frame. The Tigers were able to knot the game in the sixth on a double by Brody Gomez and a single by Rogers.

On the mound, Fort Scott's Brady Messer picked up the win, giving up six hits and five runs while fan-

ning two and walking two in two innings. Chanute's Kyson Seemster tossed 1 1/3 innings, allowing three runs (two earned) on six hits with one walk and no strikeouts in the loss.

Tiger starter Kaden Cannon collected five K's and three walks while allowing four hits and six runs (none earned) in five innings on the bump.

Rogers went 3-4 to lead the Tigers in hits while Vann, Gomez and Kanin Brown each recorded multiple hits.

**Lady Tigers vs. Chanute**  
Fort Scott took an early 2-0 lead on a sacrifice fly by Elsa Bishop that plated a run in the second inning, and a Chanute error that resulted in one run in the third inning. The Lady Tigers boost-

ed their lead on a three-run home run to left by Bryleigh Hymer in the fifth.

In the circle, Fort Scott's Lakyn Farley gave up eight hits and one run (none earned) while striking out four hitters and walking two in 6 1/3 innings. Fort Scott's Kyndal Aikin made a relief appearance. Chanute's Avery Dean allowed six runs (four earned) on seven hits with one strikeout and two walks in six innings.

Fort Scott's Aubrey Yarick and Hymer each had two hits, with Hymer, who went 2-3, leading her team with three RBIs.

Chanute's Mylee Miller, who went 1-4, led the Blue Comets with one RBI. Brynna Peter led the Blue Comets in hits with three hits in four plate appearances. While

Ava Teichgraeber went 2-4 on the day. Aly Splechter had two steals.

The Class 4A, 5A and 6A regional tournaments will be seeded today. The top 16 teams in each region will make the bracket. The higher seed will host one day in three games between May 19-22, according to the Kansas State High School Activities Association website, [www.kshsaa.org](http://www.kshsaa.org).

The Lady Tigers will play Tuesday, May 20 at Ty Cullor Field on the campus of Fort Scott Community College. The Tiger boys will play Wednesday, May 21 at the LaRoche Baseball Complex. Opponents and times are to be determined.
