Lobenstein was handling millions of buffalo skins and robes, which commanded the highest price. Orders from the Eastern states and England were pouring in and by 1872, thousands of buffalo hunters converged on the Great Plains with names like Buffalo Bill Comstock, Buffalo Bill Cody, Cross-Eyed Joe, Apache Bill, Buffalo Curley, Wyatt Earp and Pat Garrett, who fulfilled much of those orders, resulting in the near extinction of North American buffalo herds through to the mid 1880s.

In addition to his lucrative business dealings in Leavenworth, Lobenstein investments made in Kansas City real estate in a two-year period made him an estimated quarter of a million.

Having thus acquired considerable wealth and following the untimely death of his wife, Lobenstein decided to retire and consequently sold the firm to employees, Herman F. Lang and a nephew, Ben W. Lobenstein in October 1879. As Lang,

Lobenstein & Co., they manufactured saddles and harnesses and supplied the U.S. government with shoe material for the Army.

Lobenstein subsequently left Leavenworth in 1880 to travel in Europe, leaving the management of other details to Edward Carroll (1841-1917), who had been his employee in the early years. Carroll, who was by then associated with the Leavenworth National Bank, purchased what was known as the Lobenstein Block.

A year later, Lobenstein married a cousin of E.P. Willson, president of Leavenworth's Great Western Manufacturing Co. They resided in various locations on the East Coast to include Washington, D.C., and New York City, and in later years spent much of the year in Europe. Lobenstein continued his philanthropic work in Leavenworth for the Kansas Association of Friendless Women since his first wife had been a member of its board of directors upon its organization in 1868.

The change in business ownership at Third and Cherokee was comparatively brief before Stevens & Garrigues, a wholesale wagon hardware house, took over. It later became Stevens & Brace, known as the largest of its kind in the west, and by November 1889, relocated to Kansas City, as had other large Leavenworth businesses.

The Rohlfing & Co. Wholesale Grocers then purchased the property from Carroll and relocated their business from across the street. The structure was remodeled with "modern conveniences and equipment," refinished woodwork, and the exterior brick fascia painted a bright red.

The Rohlfing Company had been established in 1858 by German immigrants Frederick W. Rohlfing and Henry W. Wulfekuhler (1834-1909), who had arrived in Leavenworth via steamboat with a stock of groceries.

Rohlfing was soon bought out by H.W. and his brother, Frederick W., and the Rohlfing name retained for the business. The brothers also freighted with mule and ox trains across the plains until the completion of the Union Pacific Railroad in 1869 and married Rohlfing's sisters, Louisa

and Sophia.

Sons of Frederick and Sophia, Adolph and Fred Wulfekuhler joined the firm and continued the business until 1947. H.W. founded the Wulfekuhler State Bank in 1901 in Leavenworth until 1931, when it was closed in the early years of the Great Depression, due to the struggle for local farmers to repay their loans.

Within the past 70 years, many recall various businesses renting spaces at Third and Cherokee, such as the long-lived Keyhole Club which operated for four decades on the Third Street side.

The removal of the building was a sad occasion this past May, during National Historic Preservation Month, a month-long observance that promotes national and community pride in historic places by highlighting the social and economic benefits of historic preservation. When such historic buildings vanish from the landscape, a valuable connection to the past is severed, impacting community identity and cultural understanding.

Efforts to safeguard historic buildings present many challenges such

as the consideration of structural integrity, regulatory hurdles, the high cost of finding suitable replacement materials and difficulty in gaining public support, especially as to who should bear the financial burden to accomplish historical preservation.

The Leavenworth **County Historical Society** was founded 70 years ago, as the loss of local historic sites was then rapidly occurring. Although a nonprofit organization, unsupported by tax dollars, the Society strives to

advocate for preservation, offer education regarding local history, connect home and business owners with professional resources and encourage a community effort to explore, promote and save local history.

The Carroll Mansion Museum, 1128 Fifth Ave., has been the home of the Society for 60 years. Membership and volunteers are welcome.
