

Linn Valley discusses city hall funding sources

The Linn Valley City Council held its bi-monthly meeting at 6 p.m. on Monday, May 12, 2025, with Mayor Lew Donelson presiding and all council members present.

Donelson informed the council of two potential opportunities for funding a new City Hall building. Donelson reported that the Chamber of Commerce could potentially provide a building valued at up to \$1.5 million. The Chamber, which does this for municipalities of 2,500 population or less, would dictate the design and features of the building. Funding would likely be accomplished by a grant for 50 percent of the total cost, with the balance

provided through a loan. The other opportunity would be to apply for funding through USDA Rural Development, and it could possibly include grant money, as well.

City Clerk Mendi Cyr presented the April 2025 Financial Report which included total income of \$31,360 and total expenses of \$17,287. The vouchers were approved on a motion by Council President Robert Suppenbach.

Codes Enforcement Officer Steve German's report included 20 building permits issued in April, including one for a new residence. Violations on the Nuisance Codes Report included a citation issued for trash in a yard. Certified letters regarding a fence

complaint, an RV parked in a driveway and another for two RVs on one lot.

Public Safety Director Corey Murrison reported on police department activity during the past month, including three reports of damage from the front gate being struck, one motor vehicle accident, two separate arrests for a Protection from Abuse Order and two arrests for Possession of a Controlled Substance and a stolen handgun. Murrison also reported that he is seeking replacements for two of the department's body cameras which have stopped working. He believes the cameras should be replaced under the manufacturer's warranty.

USD 362 board rejects adding bus A/C

Amended budget, kitchen exhausts, new position are passed

Prairie View Unified School District 362's board of education has rejected adding air conditioning (A/C) to current route buses.

Voted on at the May 20 monthly meeting, the 4-2 decision turns down a pareddown request of \$109,440 to

retrofit the district fleet's nine current A/C-less buses with less than 150,000 miles.

In response to Brian Uphoff's motion and Rita Boydston's second, board members Brad Heide, Brian Lueker, Russell Pope and Wade Teagarden all voted against the measure. George Nunnemacher was not pres-

Laurie McCarthy, district transportation director, provided a district vehicle

replacement schedule and also reported that the average afternoon ridership is 503 students. Chris Johnson, Ph.D., district superintendent, alluded to a proposed \$300,000 capital outlay transportation budget for fiscal year 2026 (FY26), a practice she said "went by the wayside during COVID."

The two had proposed that \$65,000 be designated to replace a Suburban sports

utility vehicle and \$85,000 be spent for a wheelchair-accessible mini-bus to replace two current route buses, leaving space for the A/C request.

Boydston contended that the district might need to buy a new bus "if an older driver has a medical condition (caused by overheating) and wrecks a bus," but dissenting board members had expressed financial concerns previously at the April 15 monthly meeting and at an

April 24 special meeting.

Other votes, all 6-0, amend the current budget, replace required exhaust systems for the two elementary school kitchens, and create a new classified position at the middle school.

Primary in the budget amendment was a \$100,400 increase in spending authority for the food service line item to \$841,150. During a preliminary required open budget hearing, Johnson said

Council actions include split vote on deed conveyance

Hearing of the disbandment of its local Chamber of Commerce, La Cygne leaders have verbally concurred that the city's part in the annual Blast in the Park festivities will go on.

Following that Chamber notification at last Wednesday's regular council meeting by Jodi Wade, city clerk, the consensus is that the city will continue to support the budgeted fireworks show, portable toilet rentals and handle parking and trash this July 12.

Wade said possible volunteers could take up the slack this year for food, entertainment and vendors, previously part of the Chamber's co-sponsorship purvey. Whether the city assumes those roles next year would depend on if they are included in next year's city budget.

Said Tommy Capp, council president, "If the fireworks go on and others don't, it's still an event."

In answer to Capp, Wade said the fireworks last year cost around \$5,300. Mayor Debra Wilson also pointed out that city employees are paid to work the Blast, one of two city-sponsored events.

Asked by Councilman Jerome Mitzner as to "who did the majority of legwork" during last year's Blast, Wade listed City Hall employees and police force, along with volunteer firefighters and Rick James, R-La Cygne, Kansas 4th District state representative.

Zach Mathies, police chief, confirmed that Blast in the Park, a Saturday, will be a mandatory workday for his

Formal actions last week included a split 4-1 vote, with David Brenneman dissenting, on a resolution to allow Wilson to sign a deed conveyance for seven lots at 402 S. Broadway St. Brenneman has previously voiced his overall objection of the city accepting real property, his concerns dating back to a similar arrangement on property at 602 N. 5th St.

Participating via Zoom videoconference, Jeff Deane, city attorney, said that grantor Sue Duncan "is happy with the language" of the agree-

He said Wilson's signature to the agreement conveys the deed to the city upon its execution. In turn, Deane said La Cygne will satisfy back taxes and penalties to the Linn County Treasurer for 2022-
