Public notice is hereby given that the City Commission of the City of Manhattan, Kansas (the 'Issuer"), will conduct a public hearing on July 15, 2025 at 6:00 p.m., or as soon thereafter as may be heard at the City Commission Room, 1101 Poyntz Avenue, Manhattan, Kansas in regard to the issuance by the Issuer of its Industrial Revenue Bonds (Wareham Hall Project), in a principal amount not to exceed \$40,000,000 (the "Bonds") and in regard to an exemption from ad valorem taxation of property constructed or purchased with the proceeds of such Bonds. The Bonds are proposed to be issued by the Issuer under authority of K.S.A. 12-1740 et sea., as amended, to pay the costs of the acquisition, renovation, construction and equipping of a commercial facility located at 410 Poyntz Avenue and 414 Poyntz Avenue. The Issuer further intends to lease such facility to Wareham Hall Ventures, LLC, a Kansas limited liability company, or a legal entity to be formed by Wareham Hall Ventures, LLC (the "Tenant"). The governing body of the Issuer will not pass an ordinance authorizing the issuance of such revenue bonds until the public hearing has been


