Paola held a 4-2 lead in the opening game of the doubleheader, but Fort Scott rallied to win it 10-7 on Thursday, April 3.


The Paola Panthers, ranked No. 3 in the state, were 4-0 heading into the game. Fort Scott, ranked No. 5, was 5-0.
