### 35 years ago April 19, 1990

• Discovering one of the eggs he found at the Oskaloosa Easter Egg Hunt was loaded with prize slips, 6-year-old Jesse Houk quickly learned the fun of hunting Easter Eggs doesn't always end with the hunt itself. Houk, the son of Allan and Irene Houk, Oskaloosa, was one of hundreds of youths to take part in the annual event sponsored by the Oskaloosa Lions Club, April 14.

Finders of the grand prize eggs were: David Adams, Anthony Mack, Jenny Kerwin and Shane Buttram.

• An open house to show off the new \$1.56 million facility at Oskaloosa Unified School District 341 is planned for April 29.

• Area patriots could not be kept away from downtown

McLouth last weekend despite the sky's threat of rain.

The city's second annual Patriots Day parade and festivities April 15 brought quilts, crafts, military memorabilia, baseball cards, horse droppings, balloons and cotton candy.

The parade was led by Highway Patrolman Bob Baker and the 312th United States Army Reserve Band, followed by five local grand marshals. The marshals were John Bower, Louise Bradford Gilbert, Frances Harker, Leland McPherson and Myra Gladys Wellman.

### 15 years ago April 22, 2010

• City leaders of Oskaloosa are exploring a recycling option. Shawn Ball, the city's trash collector, gave a proposal to install recycling bins somewhere in the city.

The recycle containers would be 22-foot long, roll-off containers. Ball would handle all of the hauling of recyclables that would be transported to Shawnee County for processing.

• McLouth residents packed Union Street on Saturday for the annual Patriots Day Parade.

• Costs for Oskaloosa's city-wide sewer project increased significantly last Thursday night during a meeting of the city council.

The city's engineer for the project, Brian Kingsley with BG Consultants, presented two change orders to the project that brings the total cost to \$1.978 million after an increase of nearly \$193,000. The new design will also add about 60 days of construction time to the project.

Increased costs are the result of a new design for transporting sewage across a stream to the city's lagoons.
