ORDINANCE NO. 2671

AN ORDINANCE AMENDING CHANUTE MUNICIPAL CODE SECTION 8.24.010 PERTAINING TO SALE OF FIREWORKS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHANUTE, KANSAS

SECTION 1: Section 8.24.010, Chanute Municipal Code, is hereby amended to read and provide as follows

8.24.010 – Sale prohibited when–Penalty.

No person, firm or corporation shall offer fireworks for sale to individuals at retail before the 29th day of June or after the 5th day of July. Any person violating the provisions of this section shall, upon conviction thereof, be fined in any sum not exceeding \$100.00 or be imprisoned not to exceed three (3) months or be both so fined and imprisoned.

SECTION 2:
This ordinance shall take effect upon its publication in the official City newspaper. Passed and adopted by the Governing Body of the City of Chanute, Kansas, this 12th day of May
