Public Notice

ORDER FOR DEMOLITION OF PRIMARY & ACCESSORY STRUCTURES

PUBLIC NOTICE is hereby given to **Arturo Gomez Rueda** and all other parties of interest, address(s) unknown, owners of record and parties of interest of a lot and primary structure located at 402 W 6th, Pittsburg, Kansas, more particularly described as: **GOFFS WEST ADDITION, E1/2 LT 21 AND ALL LT 22, BLK 3**, said lot and the structures thereon, in the opinion of the Building Official, are being maintained in violation of City Ordinance G-1261, as adopted by the City of Pittsburg, and are dangerous, unsafe, and unsanitary structures.

In accordance with City Ordinance G-1371 you, as owner of the subject property, are hereby notified that the primary structure located at **402 W 6th** has been found, after Public Hearing held **Thursday, May 1st, 2025**, at which you did appear, to be unfit for human use or habitation. The structures are in a state of disrepair and it has been determined that the cost to renovate the structures is in excess of 50% of appraised value of the property.

As owner or interested party, you are hereby directed to demolish and remove the said structures within (30) calendar days of posting and publication of this order. Failure to comply with this Order will result in the Public Officer having said structures demolished and removed, the cost of which shall be a lien and/or a special assessment against the lot or parcel of land on which the structure is located.

It is my duty to inform you of your right to appeal this order in District Court of Crawford County, Kansas (within 30 days of the service of order) for an injunction restraining the Public Officer from carrying out the provisions of the order, and the court may, upon such petition, issue a temporary injunction restraining the Public Officer pending the final disposition of the case. The court shall hear and determine the issues raised and shall enter a final order or decree in the proceedings. In all such proceedings, the findings of the Public Officer as to facts, if supported by evidence, shall be conclusive.
