ORDINANCE NO. 649

AN ORDINANCE OF THE CITY OF ARMA, KANSAS AMENDING THE CITY WATER CODE TO ESTABLISH CHARGES FOR CONNECTION TO THE CITY WATERWORKS AND REPLACEMENT OF DAMAGED CITY WATER METERS WITHIN THE CITY OF ARMA, KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ARMA, KANSAS:

SECTION 1: Section 15-307 of the Code of the City of Arma Kansas is added to read as follows:

15-207. CONNECTION FEES.

The fees for connection to the city waterworks system shall be as follows:

(a) For connecting to water main with three-fourths inch meter - market cost;

(b) For connecting to water main with larger than a three-fourths inch tap, service line, or meter - market cost;

(c) For replacing a three-fourths inch damaged meter - market cost;

(d) For replacing a larger than a three-fourths inch damaged meter - market cost;

(e) Property owner should report all damaged meters needing replacement to the City Water Department.

(f) The City Water Department can determine upon inspection if a damaged meter needs replaced.

(g) Payment for replacement of a damaged meter shall be made within 30 days or water service to the property shall be disconnected.

PUBLIC NOTICE is hereby given that a hearing into this matter will be held, before the undersigned, in the **DOWNSTAIRS CONFERENCE ROOM** located in **CITY HALL, 201 W. 4TH** in Pittsburg, Kansas, on **JANUARY 8TH, 2026**, beginning at **9:30 a.m.** You, as the owner or party of interest shall have the right to file an answer to the complaint and to appear in person, or otherwise, and give testimony in response to the complaint.
