#### ORDINANCE NO. 2025-15 Summary

On December 22nd, 2025, the governing body of the City of Frontenac, Kansas, adopted Ordinance No. 2025-15, entitled:

#### AN ORDINANCE OF THE CITY OF FRONTENAC, KANSAS, CALLING A SPECIAL QUESTION ELECTION FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF THE CITY THE QUESTION OF LEVYING A GENERAL PURPOSE RETAILERS' SALES TAX

The Purpose of this Ordinance is to call a special question election to the qualified electors in Frontenac a question of levying a retailer's sales tax for general municipal services. A special question election shall be held in the City of Frontenac on the 3rd day of March 2026. If approved by a majority of electors voting, such sales tax shall be subject to all applicable laws and administrative rules and regulations of the Kansas Department of Revenue. The City Clerk and the County Election Officer shall cause notice of the election to be published as required by law.
