# Rules for planting trees this spring

K-State Extension news

If you're planning to plant a tree in your yard this spring, there are some steps you can take to make sure your new landscape has its best chance of success.

Kansas State University horticulture expert Cynthia Domenghini shares the following 10 rules for planting trees:

• Select the right tree for the

To avoid serious problems, choose trees that are adapted to your location. Consider whether the tree produces nuisance fruit or if there are diseaseresistant varieties available. For example, there are a number of crabapple varieties that are resistant to apple scab and rust diseases. Also consider the mature size of a tree to be sure you have enough room. Your local extension office and garden center can make tree recommendations for your region.

• Keep the tree well watered and in a shady location until planting.

When moving the tree, lift it by the root ball or pot and not by the trunk.

• Before planting, remove all wires, labels, cords or anything else tied to the plant. If left on, they may eventu-

ally girdle the branch to which they are attached.

• Dig a proper hole.

Make the hole deep enough so the root flare (point where the trunk and roots meet) is visible when planted. Plant the tree on solid ground, not fill dirt. In other words, don't dig the hole too deep and then add soil back to the hole before placing

The width of the planting hole is very important. It should be three times the width of the root ball. Loosening the soil outside the hole so it is five times the diameter of the root ball will allow the tree to spread its roots faster.

• Remove all containers from

Cut away plastic and peat

pots: roll burlap and wire baskets back into the hole, cutting as much of the excess away as possible. If you can remove the wire basket without disturbing the root ball, do it. If roots have been circling around in the container, cut them and fluff them out so they do not continue growing in a circle inside the hole becoming girdling roots

• Backfill the hole with the same soil that was removed.

Amendments such as peat moss likely do more harm than good. Make sure the soil that goes back is loosened - no clods or clumps. Add water as you fill to ensure good root to soil contact and prevent air pockets. There is no need to fertilize at

• Minimize pruning after planting.

Foliage is necessary for manufacturing energy to support a healthy tree. Heavy pruning reduces the number of leaves and consequently the amount of energy generated. Corrective pruning can be done at planting to remove dead, damaged or diseased branches or branches that are rubbing against each

• Water the tree thoroughly. Then, water once a week for the first season if there is insufficient rainfall.

• Mulch around the tree. Mulch should be 2-4 inches deep and cover an area 2 to 3 times the diameter of the root ball. Avoid mulching right up to the trunk of the tree. Leave a 3 to 6-inch gap between the mulch and the trunk to prevent damaging the tree. Mulching reduces competition from other plants, conserves moisture and

moderates soil temperature. • Stake only when necessary. Larger trees or those in windy locations may need to be staked the first year. Movement is necessary for the trunk and roots to develop properly. Staking should be designed to limit movement of the root ball rather

than immobilize the trunk.

for library time, media, specials, sensory/motor skills, and general exploration. A small room will serve as a quiet space, and the on-site kitchenette will be integrated into the curricu-

"We are learning as we go, but we hope to truly integrate the preschool into the rest of the district," Sturgeon said.
"We're hopeful that high school students on alternative pathways—especially those interested in early education—will benefit from this opportunity."

The state will provide funding for at-risk students. Those on a general education track will be charged a fee of \$750 for full-day or \$350 for a half-day students, regardless of whether they attend as peer models. The school district will supplement the program with funding until it is self sufficient.

"This is not about making a profit," said Sturgeon. "This is an educational and staffing opportunity and a way to further enhance what we already offer."

#### Leadership and Vision

Wilson, the new preschool director, brings extensive early childhood education experience and will implement the CKLA (Core Knowledge Language Arts) curriculum. She also emphasizes character development and social-emotional growth to help build a strong foundation for 3- and 4-year-olds.

"Honestly, whatever gets each student to learn best, that's what we will do," Wilson said. "I'm so excited to dig in and see what good can be done here. I have a lot of ideas."

The school has hired Edna Wells, with 13 years of experience, and Holly Ann Abel, with five years of experience, as teachers. Paraprofessional support is also being sought. Pending enrollment, more teachers will be hired as needed.

This first year will be a learning experience for the district, its staff, and the students. Sturgeon said future years will likely bring adjustments and additions to the program.

One initiative under discussion is the development of a daycare program within the building. The proposed expansion would meet a community need, build on early learning foundations, support staff recruitment and retention, and potentially strengthen the district's early education pathway.

The district also plans to eventually update the gymnasium and locker rooms in the Ozawkie building, with the goal of bringing those facilities back into regular use for Tiger

For now, USD 340 has a clear goal: a successful first year back at Ozawkie.

"Jefferson West desperately needed a preschool and we are lucky to have this building,' said Sturgeon. "We are happy to bring it back to the district, and bring part of the district back to Ozawkie."

In presenting the petition to the commissioners for their consideration, Metzger said the vacation of the setbacks would eliminate the need for the petitioners, Daniel and Linda Foltz, to have to replat the property sometime in the future.

The property is zoned Suburban Residential.
